- 2 An act to enact the uniform securities act (2002) relating to
- 3 the issuance, offer, sale, or purchase of securities; to prohibit

- 10 under the investment company act of 1940, in a security of a class

- 14 (i) The issuer of the security is engaged in business, the

- 19 or combination of the business with, or an acquisition of, an

- 24 unsold allotment to, or a subscription or participation by, the
- 25 broker-dealer as an underwriter of the security or a
- 26 redistribution.
- 27 (iv) A nationally recognized securities manual or its

- 1 electronic equivalent designated by rule or order under this act or
- 2 a record filed with the securities and exchange commission that is
- 3 publicly available contains all of the following:
- 4 (A) A description of the business and operations of the
- 5 issuer.
- 6 (B) The names of the issuer's executive officers and the names
- 7 of the issuer's directors, if any.
- 8 (C) An audited balance sheet of the issuer as of a date within
- 9 18 months before the date of the transaction or, in the case of a
- 10 reorganization or merger, and when the parties to the
- 11 reorganization or merger each had an audited balance sheet, a pro

- 2 \$2,000,000.00 based on an audited balance sheet as of a date within
- 3 18 months before the date of the transaction or, in the case of a
- 4 reorganization or merger when the parties to the reorganization or
- 5 merger each had an audited balance sheet as of a date within 18
- 6 months before the date of the transaction, a pro forma balance
- 7 sheet for the combined entity.
- 8 (c) A nonissuer transaction by or through a broker-dealer
- 9 registered or exempt from registration under this act in a security
- 10 of a foreign issuer that is a margin security defined in
- 11 regulations or rules adopted by the board of governors of the
- 12 federal reserve system.
- 13 (d) A nonissuer transaction by or through a broker-dealer
- 14 registered or exempt from registration under this act in an
- 15 outstanding security if the guarantor of the security files reports
- 16 with the securities and exchange commission under the reporting
- 17 requirements of section 13 or 15(d) of the securities exchange act
- **18** of 1934, 15 USC 78m or 78o.
- 19 (e) A nonissuer transaction by or through a broker-dealer
- 20 registered or exempt from registration under this act in a security
- 21 that meets 1 or more of the following:
- 22 (i) Is rated at the time of the transaction by a nationally
- 23 recognized statistical rating organization in 1 of its 4 highest
- 24 rating categories.
- 25 (ii) Has a fixed maturity or a fixed interest or dividend, if
- 26 both of the following are met:
- 27 (A) A default has not occurred during the current fiscal year

- 1 or within the 3 previous fiscal years or during the existence of
- 2 the issuer and any predecessor if less than 3 fiscal years, in the
- 3 payment of principal, interest, or dividends on the security.
- 4 (B) The issuer is engaged in business, is not in the
- 5 organizational stage or in bankruptcy or receivership, and is not
- 6 and has not been within the previous 12 months a blank check, blind
- 7 pool, or shell company that has no specific business plan or
- 8 purpose or has indicated that its primary business plan is to
- 9 engage in a merger or combination of the business with, or an
- 10 acquisition of, an unidentified person.
- 11 (f) A nonissuer transaction by or through a broker-dealer
- 12 registered or exempt from registration under this act effecting an
- 13 unsolicited order or offer to purchase.
- 14 (g) A nonissuer transaction executed by a bona fide pledgee
- 15 without any purpose of evading this act.
- 16 (h) A nonissuer transaction by a federal covered investment
- 17 adviser with investments under management in excess of
- 18 \$100,000,000.00 acting in the exercise of discretionary authority
- 19 in a signed record for the account of others.
- 20 (i) A transaction in a security, whether or not the security
- 21 or transaction is otherwise exempt, in exchange for 1 or more bona
- 22 fide outstanding securities, claims, or property interests, or
- 23 partly in exchange and partly for cash, if the terms and conditions
- 24 of the issuance and exchange or the delivery and exchange and the
- 25 fairness of the terms and conditions have been approved by the
- 26 administrator at a hearing.
- 27 (j) A transaction between the issuer or other person on whose

- 1 behalf the offering is made and an underwriter, or among
- 2 underwriters.
- 3 (k) A transaction in a note, bond, debenture, or other
- 4 evidence of indebtedness secured by a mortgage or other security
- 5 agreement if all of the following are met:
- 6 (i) The note, bond, debenture, or other evidence of
- 7 indebtedness is offered and sold with the mortgage or other
- 8 security agreement as a unit.
- 9 (ii) A general solicitation or general advertisement of the
- 10 transaction is not made.
- 11 (iii) A commission or other remuneration is not paid or given,
- 12 directly or indirectly, to a person not registered under this act
- 13 as a broker-dealer or as an agent.
- 14 (l) A transaction by an executor, administrator of an estate,
- 15 sheriff, marshal, receiver, trustee in bankruptcy, guardian, or
- 16 conservator.
- 17 (m) A sale or offer to sell to any of the following:
- 18 (i) An institutional investor.
- 19 (ii) A federal covered investment adviser.
- 20 (iii) Any other person exempted by rule or order under this act.
- 21 (n) A sale or an offer to sell securities by or on behalf of
- 22 an issuer, if the transaction is part of a single issue in which
- 23 all of the following are met:
- 24 (i) There are not more than 50 purchasers in this state during
- 25 any 12 consecutive months, other than those designated in
- 26 subdivision (m).
- 27 (ii) There is no general solicitation or general advertising

- 1 used in connection with the offer to sell or sale of the
- 2 securities.
- 3 (iii) A commission or other remuneration is not paid or given,
- 4 directly or indirectly, to a person other than a broker-dealer
- 5 registered under this act or an agent registered under this act for
- 6 soliciting a prospective purchaser in this state.
- 7 (iv) The issuer reasonably believes that all the purchasers in
- 8 this state other than those designated in subdivision (m) are
- 9 purchasing for investment.
- 10 (o) A transaction under an offer to existing security holders
- 11 of the issuer, including persons that at the date of the
- 12 transaction are holders of convertible securities, options, or
- 13 warrants, if a commission or other remuneration, other than a
- 14 standby commission, is not paid or given, directly or indirectly,
- 15 for soliciting a security holder in this state.
- 16 (p) An offer to sell, but not a sale, of a security not exempt
- 17 from registration under the securities act of 1933 if both of the
- 18 following are met:
- 19 (i) A registration or offering statement or similar record as
- 20 required under the securities act of 1933 has been filed, but is
- 21 not effective, or the offer is made in compliance with rule 165
- 22 adopted under the securities act of 1933, 17 CFR 230.165.
- 23 (ii) A stop order of which the offeror is aware has not been
- 24 issued against the offeror by the administrator or the securities
- 25 and exchange commission, and an audit, inspection, or proceeding
- 26 that is public and may culminate in a stop order is not known by
- 27 the offeror to be pending.

- 1 (q) An offer to sell, but not a sale, of a security exempt
- 2 from registration under the securities act of 1933 if all of the
- 3 following are met:
- 4 (i) A registration statement has been filed under this act, but
- 5 is not effective.
- 6 (ii) A solicitation of interest is provided in a record to
- 7 offerees in compliance with a rule adopted by the administrator
- 8 under this act.
- 9 (iii) A stop order of which the offeror is aware has not been
- 10 issued by the administrator under this act, and an audit,
- 11 inspection, or proceeding that may culminate in a stop order is not
- 12 known by the offeror to be pending.
- 13 (r) A transaction involving the distribution of the securities
- 14 of an issuer to the security holders of another person in
- 15 connection with a merger, consolidation, exchange of securities,
- 16 sale of assets, or other reorganization to which the issuer, or its
- 17 parent or subsidiary, and the other person, or its parent or
- 18 subsidiary, are parties.
- 19 (s) A rescission offer, sale, or purchase under section 510.
- 20 (t) An offer or sale of a security to a person not resident in
- 21 this state and not present in this state if the offer or sale does
- 22 not constitute a violation of the laws of the state or foreign
- 23 jurisdiction in which the offeree or purchaser is present and is
- 24 not part of an unlawful plan or scheme to evade this act.
- 25 (u) An offer or sale of a security pursuant to an employee's
- 26 stock purchase, savings, option, profit-sharing, pension, or
- 27 similar employees' benefit plan, including any securities, plan

- 1 interests, and guarantees issued under a compensatory benefit plan
- 2 or compensation contract, contained in a record, established by the
- 3 issuer, its parents, its majority-owned subsidiaries, or the
- 4 majority-owned subsidiaries of the issuer's parent for the
- 5 participation of their employees including any of the following:
- 6 (i) Offers or sales of those securities to directors; general
- 7 partners; trustees, if the issuer is a business trust; officers; or
- 8 consultants and advisors.
- 9 (ii) Family members who acquire those securities from those
- 10 persons through gifts or domestic relations orders.
- 11 (iii) Former employees, directors, general partners, trustees,
- 12 officers, consultants, and advisors if those individuals were
- 13 employed by or providing services to the issuer when the securities
- 14 were offered.
- (iv) Insurance agents who are exclusive insurance agents of the
- 16 issuer, its subsidiaries or parents, or who derive more than 50% of
- 17 their annual income from those organizations.
- (v) A transaction involving any of the following:
- 19 (i) A stock dividend or equivalent equity distribution, whether
- 20 the corporation or other business organization distributing the
- 21 dividend or equivalent equity distribution is the issuer or not, if
- 22 nothing of value is given by stockholders or other equity holders
- 23 for the dividend or equivalent equity distribution other than the
- 24 surrender of a right to a cash or property dividend if each

- 27 (ii) An act incident to a judicially approved reorganization in

- 1 which a security is issued in exchange for 1 or more outstanding
- 2 securities, claims, or property interests, or partly in exchange
- 3 and partly for cash.
- 4 (iii) The solicitation of tenders of securities by an offeror in
- 5 a tender offer in compliance with rule 162 adopted under the
- 6 securities act of 1933, 17 CFR 230.162.
- 7 (w) Subject to subsection (2), a nonissuer transaction in an
- 8 outstanding security by or through a broker-dealer registered or
- 9 exempt from registration under this act, if both of the following
- 10 are met:
- 11 (i) The issuer is a reporting issuer in a foreign jurisdiction
- 12 designated in subsection (2)(a), or by rule or order of the
- 13 administrator, and has been subject to continuous reporting
- 14 requirements in the foreign jurisdiction for not less than 180 days
- 15 before the transaction.
- 16 (ii) The security is listed on the foreign jurisdiction's
- 17 securities exchange that has been designated in subsection (2)(a),
- 18 or by rule or order under this act, or is a security of the same
- 19 issuer that is of senior or substantially equal rank to the listed
- 20 security or is a warrant or right to purchase or subscribe to any
- 21 of the foregoing.
- 22 (x) Any offer or sale of a security by an issuer under section
- 23 202a.
- 24 (y) Any offer or sale of a security that meets the
- 25 requirements for the federal exemption for a regulation A offering
- 26 under section 3(b) of the securities act of 1933, 15 USC 77c(b),
- 27 and SEC rule 251, 17 CFR 230.251, if the offer or sale meets all of

- 1 the following requirements:
- 2 (i) The issuer has filed SEC form 1A with the securities and
- 3 exchange commission with respect to the regulation A offering, in a
- 4 manner acceptable to the securities and exchange commission, and in
- 5 that filing the issuer has satisfied all of the requirements of 17
- 6 CFR 230.251 to 230.263 inclusively, including the filing of the
- 7 regulation A offering circular required under 17 CFR 230.253.
- 8 (ii) At least 10 days before commencing an offering of
- 9 securities in reliance on this exemption or the use of any publicly
- 10 available website in connection with an offering of securities in
- 11 reliance on this exemption, the issuer files a notice with the
- 12 administrator, in writing or in electronic form as specified by the
- 13 administrator, that contains all of the following:
- 14 (A) A notice of claim of exemption from registration,
- 15 specifying that the issuer intends to conduct an offering in
- 16 reliance on a regulation A exemption, accompanied by a
- 17 nonrefundable filing fee of \$100.00 for filing the exemption
- 18 notice. The fees paid to the administrator under this sub-
- 19 subparagraph shall be used to pay the costs incurred in

- 2 (iii) The sum of all cash and other consideration to be received
- 3 for all sales of the security in reliance on this exemption does
- 4 not exceed the amount set forth in subsection (b) of 17 CFR
- 5 230.251, less the aggregate amount received for all sales of
- 6 securities by the issuer within the 12 months before the first
- 7 offer or sale made in reliance on this exemption.
- 8 (iv) The issuer does not accept more than \$10,000.00 from any
- 9 single purchaser unless the purchaser is an accredited investor as
- 10 defined by rule 501 of SEC regulation D, 17 CFR 230.501. The issuer
- 11 may rely on confirmation that the purchaser is an accredited
- 12 investor from a licensed broker-dealer or another third party in
- 13 making a determination that the purchaser is an accredited
- 14 investor. Every fifth year, the administrator shall cumulatively
- 15 adjust the \$10,000.00 limitation amount described in this
- 16 subparagraph to reflect the change in the consumer price index for
- 17 all urban consumers published by the federal bureau of labor
- 18 statistics, rounding the dollar limitation to the nearest \$100.00.
- 19 (Z) ANY SECONDARY OFFER, SALE, PURCHASE, OR TRADE OF

- 3 (D) A PERSON THAT IS REGISTERED AS A MICHIGAN INVESTMENT

- 5 CAPACITY AS A MICHIGAN INVESTMENT MARKET.
- 6 (3) A broker-dealer, or an issuer engaged in offering,
- 7 offering to purchase, purchasing, or selling securities in this
- 8 state, shall not directly or indirectly employ or associate with an
- 9 individual to engage in an activity related to securities
- 10 transactions in this state if the registration of the individual is
- 11 suspended or revoked or the individual is barred from employment or
