## SUBSTITUTE FOR HOUSE BILL NO. 5439

A bill to authorize the growing and cultivating of industrial hemp for research purposes; to authorize the receipt and expenditure of funding for research related to industrial hemp; and to prescribe the powers and duties of certain state agencies and officials and colleges and universities in this state.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1. This act shall be known and may be cited as the
- 2 "industrial hemp research act".
- 3 Sec. 2. As used in this act:
- 4 (a) "Department" means the department of agriculture and rural
- 5 development.
- 6 (b) "Fund" means the industrial hemp research fund created in
- 7 section 4.

- 1 (c) "Industrial hemp" means the plant Cannabis sativa L. and
- 2 any part of the plant, whether growing or not, with a delta-9-
- 3 tetrahydrocannabinol concentration of not more than 0.3% on a dry
- 4 weight basis.
- 5 Sec. 3. (1) The department or a college or university in this
- 6 state may grow or cultivate, or both, industrial hemp for purposes
- 7 of research conducted under an agricultural pilot program or other
- 8 agricultural or academic research project.
- 9 (2) The department or a college or university that transports
- 10 industrial hemp as part of a research project authorized under this
- 11 act shall include along with a shipment of industrial hemp a letter
- 12 on the department's or the college's or university's letterhead
- 13 that provides notice that the shipment includes industrial hemp
- 14 authorized under the industrial hemp research act.
- 15 (3) A college or university in this state may receive direct
- 16 grants from the federal government or any other source for the
- 17 purpose of conducting research authorized under this act.
- 18 Sec. 4. (1) The industrial hemp research fund is created
- 19 within the state treasury.
- 20 (2) The state treasurer may receive money or other assets from
- 21 any source for deposit into the fund, including federal research
- 22 grants. The state treasurer shall direct the investment of the
- 23 fund. The state treasurer shall credit to the fund interest and
- 24 earnings from fund investments.
- 25 (3) Money in the fund at the close of the fiscal year shall
- 26 remain in the fund and shall not lapse to the general fund.
- 27 (4) The department shall be the administrator of the fund for

- 1 auditing purposes.
- 2 (5) The department shall expend money from the fund, upon
- 3 appropriation, only for 1 or more of the following purposes:
- 4 (a) Research into growing or cultivating, or both, industrial
- 5 hemp.
- 6 (b) Providing grants to colleges or universities in this state
- 7 to conduct research into growing or cultivating, or both,
- 8 industrial hemp.
- 9 Enacting section 1. This act does not take effect unless House
- 10 Bill No. 5440 of the 97th Legislature is enacted into law.
