SENATE BILL No. 674

November 12, 2013, Introduced by Senators WARREN, GREEN, JONES, HOPGOOD, SMITH, ANANICH, SCHUITMAKER, HOOD, GREGORY, WHITMER and ANDERSON and referred to the Committee on Government Operations.

A bill to prohibit discriminatory practices, policies, and customs in the exercise of the right to breastfeed; to provide for enforcement of the right to breastfeed; and to provide remedies.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 1. (1) This act shall be known and may be cited as the
 "breastfeeding antidiscrimination act".
 - (2) As used in this act:
 - (a) "Place of public accommodation" means a business, an educational institution, or a refreshment, entertainment,
- 6 recreation, health, or transportation facility of any kind, whether
- 7 licensed or not, whose goods, services, facilities, privileges,
- 8 advantages, or accommodations are extended, offered, sold, or
- 9 otherwise made available to the public.

- 1 (b) "Public service" means a public facility, department,
- 2 agency, board, or commission owned, operated, or managed by or on
- 3 behalf of this state or a subdivision of this state, by a county,
- 4 city, village, township, or independent or regional district in
- 5 this state, or by a tax-exempt private agency established to
- 6 provide service to the public, except that public service does not
- 7 include a state or county correctional facility with respect to
- 8 actions or decisions regarding an individual serving a sentence of
- 9 imprisonment.
- 10 Sec. 2. Except where expressly permitted by state or federal
- 11 statute or a regulation promulgated thereunder, a person with
- 12 control over a public accommodation or public service shall not do
- 13 any of the following:
- 14 (a) Deny the full and equal enjoyment of the goods, services,
- 15 facilities, privileges, advantages, or accommodations of a place of
- 16 public accommodation or public service to a woman because she is
- 17 breastfeeding a child.
- 18 (b) Print, circulate, post, mail, or otherwise cause to be
- 19 published a statement, advertisement, notice, or sign that
- 20 indicates any of the following:
- (i) That the full and equal enjoyment of the goods, services,
- 22 facilities, privileges, advantages, or accommodations of a place of
- 23 public accommodation or public service will be refused, withheld
- 24 from, or denied a woman because she is breastfeeding a child.
- 25 (ii) That a woman's patronage of or presence at a place of
- 26 public accommodation is objectionable, unwelcome, unacceptable, or
- 27 undesirable because she is breastfeeding a child.

Senate Bill No. 674 as amended June 11, 2014

- 1 Sec. 3. (1) A person alleging a violation of this act may
- 2 bring a civil action in a court of appropriate jurisdiction for
- 3 appropriate injunctive relief, actual damages or presumed damages
- 4 of \$200.00, or both injunctive relief and actual or presumed
- 5 damages.
- 6 (2) In addition to the relief under subsection (1), a court
- 7 rendering a judgment in an action brought under this act may award
- 8 all or a portion of the costs of litigation, including reasonable
- 9 attorney fees and witness fees, to the complainant in the action if
- 10 the court determines that the award is appropriate.
