SUBSTITUTE FOR

SENATE BILL NO. 49

A bill to amend 1927 PA 372, entitled

"An act to regulate and license the selling, purchasing, possessing, and carrying of certain firearms, gas ejecting devices, and electro-muscular disruption devices; to prohibit the buying, selling, or carrying of certain firearms, gas ejecting devices, and electro-muscular disruption devices without a license or other authorization; to provide for the forfeiture of firearms and electro-muscular disruption devices under certain circumstances; to provide for penalties and remedies; to provide immunity from civil liability under certain circumstances; to prescribe the powers and duties of certain state and local agencies; to prohibit certain conduct against individuals who apply for or receive a license to carry a concealed pistol; to make appropriations; to prescribe certain conditions for the appropriations; and to repeal all acts and parts of acts inconsistent with this act,"

(MCL 28.421 to 28.435) by adding section 1b.

- 3 442, MCL 15.231 TO 15.246, AND SHALL NOT BE DISCLOSED TO ANY
- 4 PERSON, EXCEPT AS OTHERWISE PROVIDED BY THIS SECTION.

- 1 (2) FIREARMS RECORDS MAY ONLY BE ACCESSED AND DISCLOSED FOR
- 2 THE FOLLOWING PURPOSES:
- 3 (A) A PEACE OFFICER HAS PROBABLE CAUSE TO BELIEVE THAT THE
- 4 INDIVIDUAL WHOSE FIREARMS RECORDS ARE THE SUBJECT OF DISCLOSURE
- 5 POSES A THREAT TO HIMSELF OR HERSELF OR OTHER INDIVIDUALS.
- 6 (B) A PEACE OFFICER HAS PROBABLE CAUSE TO BELIEVE THAT THE
- 7 INDIVIDUAL WHOSE FIREARMS RECORDS ARE THE SUBJECT OF DISCLOSURE HAS
- 8 COMMITTED AN OFFENSE WITH THE PISTOL THAT VIOLATES A LAW OF THIS
- 9 STATE, ANOTHER STATE, OR THE UNITED STATES.
- 10 (C) A PEACE OFFICER HAS PROBABLE CAUSE TO BELIEVE THAT THE
- 11 PISTOL THAT IS THE SUBJECT OF THE FIREARMS RECORDS SEARCH WAS USED
- 12 DURING THE COMMISSION OF AN OFFENSE THAT VIOLATES A LAW OF THIS
- 13 STATE, ANOTHER STATE, OR THE UNITED STATES.
- 14 (D) TO ENSURE THE SAFETY OF A PEACE OFFICER BEFORE A LAWFUL
- 15 SEARCH AND SEIZURE.
- 16 (E) FOR PURPOSES OF THIS ACT.
- 17 (3) A PERSON WHO INTENTIONALLY VIOLATES SUBSECTION (2) IS
- 18 GUILTY OF A CRIME AS FOLLOWS:
- 19 (A) FOR A FIRST OFFENSE, THE PERSON IS GUILTY OF A MISDEMEANOR
- 20 PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 93 DAYS OR A FINE OF
- 21 NOT MORE THAN \$500.00, OR BOTH.
- 22 (B) FOR A SECOND OR SUBSEQUENT OFFENSE, THE PERSON IS GUILTY
- 23 OF A FELONY PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 4 YEARS OR
- 24 A FINE OF NOT MORE THAN \$2,000.00, OR BOTH.
