A bill to amend 1933 PA 167, entitled "General sales tax act,"

by amending section 18 (MCL 205.68), as amended by 2008 PA 438.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 18. (1) A person liable for any tax imposed under this

2 act shall keep accurate and complete beginning and annual inventory 3 and purchase records of additions to inventory, complete daily 4 sales records, receipts, invoices, bills of lading, and all 5 pertinent documents in a form the department requires. If an 6 exemption from the tax under this act is claimed by a person 7 because the sale is for resale at retail, a record shall be kept of the sales tax license number if the person has a sales tax license. These records shall be retained for a period of 4 years after the 10 tax imposed under this act to which the records apply is due or as

- 7 buyer and taxpayer. Renewal of a blanket exemption claim or an
- 8 update of exemption claim information or data elements is not

- 17 INVOLVES THE USE OF CIRCUMSTANTIAL EVIDENCE TO DETERMINE A
- 18 LIABILITY FOR THE TAX UNDER THIS ACT BASED ON OMITTED INCOME,
- 19 OVERSTATED DEDUCTIONS OR EXPENSES, OR BOTH.
