HOUSE BILL No. 5862

September 30, 2014, Introduced by Reps. Price, Walsh, Santana, Zemke and Lane and referred to the Committee on Local Government.

A bill to amend 1956 PA 218, entitled "The insurance code of 1956,"

by amending sections 102, 2227, and 2845 (MCL 500.102, 500.2227, and 500.2845), section 102 as amended by 2000 PA 252, section 2227 as added by 1998 PA 217, and section 2845 as amended by 1998 PA 216.

- 1 Sec. 102. AS USED IN THIS ACT:
 - (A) (1) "Commissioner" as used in this act means the commissioner of the office of financial and insurance services.DIRECTOR.
 - (B) (2) "Department" as used in this act means the office of financial and insurance services. DEPARTMENT OF INSURANCE AND FINANCIAL SERVICES.

- 3 Sec. 2227. (1) If a claim is filed for a loss to insured real

- 7 withhold from payment 25% of the actual cash value of the insured

- 18 invoices, receipts, and other similar papers evidencing both the
- 19 work performed or to be performed and the materials used or to be
- 20 used by all contractors performing repair, replacement, or removal
- 21 services with respect to FOR the insured real property, other than
- 22 a contractor subject to subdivision (b).
- 23 (b) An affidavit executed by the contractor that has performed
- 24 the greatest amount of repair or replacement work on the structure,
- 25 or that has done most of the clearing and removal work if structure
- 26 repair or replacement is not to be performed. The contractor shall
- 27 attach to the affidavit all pertinent contracts, invoices, and

- 1 receipts and shall swear that these attached papers correctly
- 2 indicate the nature and extent of the work performed to date by the
- 3 contractor and the materials used.
- 4 (c) An inspection of the insured real property to verify that
- 5 repair, replacement, or clearing has been completed in accordance
- 6 with subsection (5).
- 7 (7) If with respect to a loss, reasonable proof is not
- 8 received by or shown to an authorized representative of the city,
- 9 village, or township designated by the governing body of the city,
- 10 village, or township within 120 days after the policy proceeds
- 11 portion was received by the treasurer, the city, village, or
- 12 township shall use the retained proceeds to secure, repair, or
- 13 demolish the damaged or destroyed structure and clear the INSURED
- 14 property in question, so that the structure and property are in
- 15 compliance COMPLY with local code requirements and applicable
- 16 ordinances of the city, village, or township. Any THE CITY,
- 17 VILLAGE, OR TOWNSHIP SHALL RETURN TO THE INSURED ANY unused portion
- 18 of the retained proceeds. shall be returned to the insured. The
- 19 city, village, or township may extend the 120-day time period
- 20 listed in UNDER this subsection.
- 21 (8) There is no liability on the part of, and a cause of
- 22 action shall not arise against, an insurer or an agent or employee
- 23 of an insurer for withholding or transferring money in the course
- 24 of complying or attempting to comply with this section. If there is
- 25 a dispute with a lienholder concerning the distribution of an
- 26 amount withheld from payment under this section, the insurer may
- 27 file an action in circuit court to identify all parties that may

- 1 have a financial interest in the withheld amount and to determine
- 2 how the withheld amount should be distributed.
- 3 (9) This section applies only to property located in a city,
- 4 village, or township described in subsection (12) if the city,
- 5 village, or township pursuant to a resolution by its governing body
- 6 notifies the commissioner DIRECTOR in writing that the city,
- 7 village, or township has established a trust or escrow account to
- 8 be used as prescribed in this section and intends to uniformly
- 9 apply this section with respect to all property located within the
- 10 city, village, or township following written notification to the
- 11 commissioner. DIRECTOR. The commissioner DIRECTOR shall prepare and
- 12 distribute a list of all cities, villages, and townships that have
- 13 elected to apply this section to all insurance companies
- 14 transacting property insurance in this state.
- 15 (10) A city, village, or township may apply to be added to the
- 16 list PREPARED UNDER SUBSECTION (9) by making a written request for
- 17 addition to the commissioner. DIRECTOR. When a written request for
- 18 addition from a city, village, or township has been received by the
- 19 commissioner, DIRECTOR, an amended list shall be prepared and
- 20 distributed indicating the addition. The addition shall be IS
- 21 effective on the date specified by the commissioner DIRECTOR in the
- 22 amendment. The commissioner DIRECTOR shall notify the city,
- 23 village, township, and insurance companies of the effective date of
- 24 the addition which shall be effective not less than 30 days after
- 25 receipt of notice by the insurance company. A city, village, or
- 26 township shall not apply this section to any loss that occurred
- 27 before the effective date of the addition.

- 1 (11) A city, village, or township may request to be deleted
- 2 from the list PREPARED UNDER SUBSECTION (9) or may cease to apply
- 3 this section for a period of not less than 6 months upon not less
- 4 than 30 days' written notice to the commissioner. DIRECTOR. After
- 5 receipt of a request to be deleted from the list, the commissioner
- 6 DIRECTOR shall prepare and distribute an amendment to the list
- 7 indicating the deletion. The deletion shall be IS effective on the
- 8 date specified by the commissioner DIRECTOR in the amendment. The
- 9 commissioner DIRECTOR shall notify the city, village, township, and
- 10 insurance companies of the effective date of the deletion which
- 11 shall be effective not less than 30 days after receipt of the
- 12 notice by the insurance company. A city, village, or township shall
- 13 continue to apply this section to any loss that occurred before the
- 14 effective date of the deletion, notwithstanding the deletion.
- 15 (12) This section applies only to insured real property
- 16 located in cities, villages, and townships that are located in
- 17 counties with a population of less than 425,000 except that this
- 18 section does not apply to insured real property located in cities,
- 19 villages, and townships that are located in counties with a
- 20 population of less than 425,000 if the city, village, or township
- 21 has a population of 50,000 or more. This section applies to insured
- 22 real property located in a city, village, or township that has
- 23 elected to apply this section as provided in subsection (9) or
- **24** (10).
- 25 (13) The withholding requirements of this section do not apply
- 26 if all of the following occur:
- 27 (a) Within 15 days after agreement on a final settlement

- 1 between the insured and the insurer, the insured has filed with the
- 2 insurer evidence of a contract to repair as described in subsection
- **3** (6).
- 4 (b) The insured consents to the payment of funds MONEY
- 5 directly to the contractor performing the repair services. Funds
- 6 MONEY released under this subdivision may be forwarded only to a
- 7 contractor performing the repair services on the insured property.
- 8 (c) On receipt of the contract to repair, the insurer gives
- 9 notice to the city, village, or township in which the property is
- 10 situated LOCATED that there will not be a withholding under this
- 11 section because of the repair contract.
- 12 (14) If the insured and the insurer have agreed on the
- 13 demolition costs or the debris removal costs as part of the final
- 14 settlement of the real property insured claim, the insurer shall
- 15 withhold 1 of the following sums, AMOUNTS, whichever sum is the
- 16 largest, and shall pay that sum AMOUNT in accordance with this
- 17 section:
- 18 (a) The agreed cost of demolition or debris removal.
- 19 (b) Twenty-five percent UNTIL DECEMBER 31, 2014, 25% of the
- 20 actual cash value of the insured real property at the time of loss
- 21 so long as IF this amount for residential property does not exceed
- 22 \$6,000.00 adjusted annually beginning June 1, 1999 in accordance
- 23 with the consumer price index.
- 24 (C) BEGINNING JANUARY 1, 2015, 25% OF THE ACTUAL CASH VALUE OF
- 25 THE INSURED REAL PROPERTY AT THE TIME OF THE LOSS IF THIS AMOUNT
- 26 FOR RESIDENTIAL PROPERTY DOES NOT EXCEED \$12,000.00 ADJUSTED
- 27 JANUARY 1 OF EACH YEAR IN ACCORDANCE WITH THE CONSUMER PRICE INDEX.

- 1 (D) (c) Twenty-five percent UNTIL DECEMBER 31, 2014, 25% of
- 2 the final settlement of the insured real property claim so long as
- 3 IF this amount for residential property does not exceed \$6,000.00
- 4 adjusted annually beginning June 1, 1999 in accordance with the
- 5 consumer price index.
- 6 (E) BEGINNING JANUARY 1, 2015, 25% OF THE FINAL SETTLEMENT OF
- 7 THE INSURED REAL PROPERTY CLAIM IF THIS AMOUNT FOR RESIDENTIAL
- 8 PROPERTY DOES NOT EXCEED \$12,000.00 ADJUSTED JANUARY 1 OF EACH YEAR
- 9 IN ACCORDANCE WITH THE CONSUMER PRICE INDEX.
- 10 (15) This section applies only to final settlements that
- 11 exceed 49% of the insurance on the insured real property.
- 12 (16) If an insurer withholds payment under a policy in good
- 13 faith because of suspected arson, fraud, or other question
- 14 concerning coverage, this section does not apply until the issue or
- 15 question is resolved and final settlement is made.
- 16 (17) As used in this section:
- 17 (a) "Consumer price index" means that term as defined in
- **18** section 2080.
- 19 (b) "Final settlement" means a determination of the amount due
- 20 and owing to the insured for a loss to insured real property, but
- 21 does not include contents damage, losses to personal property, or
- 22 additional coverage not contained in the building coverage portion
- 23 of the fire insurance policy, which determination is made by any of
- 24 the following means:
- 25 (i) Acceptance of a proof of loss by the insurer.
- 26 (ii) Execution of a release by the insured.
- 27 (iii) Acceptance of an arbitration award by both the insured and

- 1 the insurer.
- (iv) Judgment of a court of competent jurisdiction.
- 3 (c) "Home insurance" means that term as defined in section
- **4** 2103.
- 5 (d) "Residential property" means property on which home
- 6 insurance can be issued.
