THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 32. (1) Definitions of words and phrases and rules of construction prescribed in any statute that are made applicable to all statutes of this state also apply to rules unless clearly indicated to the contrary.

(2) A rule or exception to a rule shall MUST not discriminate in favor of or against any person. A person affected by a rule is entitled to the same benefits as any other person under the same or similar circumstances.

- 1 (3) The violation of a rule is a crime when so IF provided by
- 2 statute. A UNLESS PROVIDED BY STATUTE, A rule shall MUST not make
- 3 DESIGNATE an act or omission to act AS a crime or prescribe a

- 27 (l) (j) An estimate of the actual statewide compliance costs

- 2 (M) (k) A demonstration that the proposed rule is necessary
- 3 and suitable to achieve its purpose in proportion to the burdens it

- 5 (N) $\frac{(l)}{(l)}$ An estimate of the actual statewide compliance costs
- 6 of the proposed rule on businesses and other groups.
- 7 (O) (m) An identification of any disproportionate impact the
- 8 proposed rule may have on small businesses because of their size.
- 9 (P) (n)—An identification of the nature of any report required
- 10 and the estimated cost of its preparation by small businesses
- 11 required to comply with the proposed rule.
- (Q) (O)—An analysis of the costs of compliance for all small
- 13 businesses affected by the proposed rule, including costs of
- 14 equipment, supplies, labor, and increased administrative costs.
- 15 (R) (p)—An identification of the nature and estimated cost of
- 16 any legal consulting and accounting services that small businesses
- 17 would incur in complying with the proposed rule.
- 18 (S) (a)—An estimate of the ability of small businesses to
- 19 absorb the costs estimated under subdivisions (n) to (R)
- 20 without suffering economic harm and without adversely affecting
- 21 competition in the marketplace.
- 22 (T) (r) An estimate of the cost, if any, to the agency of
- 23 administering or enforcing a rule that exempts or sets lesser
- 24 standards for compliance by small businesses.
- 25 (U) (s)—An identification of the impact on the public interest
- 26 of exempting or setting lesser standards of compliance for small
- 27 businesses.

- 1 (V) (t) A statement describing the manner in which the agency
- 2 reduced the economic impact of the rule on small businesses or a
- 3 statement describing the reasons such a reduction was not feasible.
- 4 (W) (u) A statement describing how the agency has involved
- 5 small businesses in the development of the rule.
- 6 (X) (v) An estimate of the primary and direct benefits of the
- 7 rule.
- 8 (Y) (w) An estimate of any cost reductions to businesses,
- 9 individuals, groups of individuals, or governmental units as a
- 10 result of the rule.
- 11 (Z) (x)—An estimate of any increase in revenues to state or
- 12 local governmental units as a result of the rule.
- (AA) (y)—An estimate of any secondary or indirect benefits of
- 14 the rule.
- 15 (BB) (z) An identification of the sources the agency relied on
- 16 in compiling the regulatory impact statement, including the
- 17 methodology utilized USED in determining the existence and extent
- 18 of the impact of a proposed rule and a cost-benefit analysis of the
- 19 proposed rule.
- 20 (CC) (aa)—A detailed recitation of the efforts of the agency
- 21 to comply with the mandate to reduce the disproportionate impact of
- 22 the rule upon ON small businesses as described in section 40(1)(a)

- 24 (DD) (bb)—Any other information required by the office.
- 25 (4) The AN agency shall electronically transmit the regulatory
- 26 impact statement required under subsection (3) to the office at
- 27 least 28 days before the public hearing required under section 41.

- 1 The agency shall not hold the public hearing until the regulatory
- 2 impact statement has been reviewed and approved by the office. The
- 3 agency shall also electronically transmit a copy of the regulatory
- 4 impact statement to the committee before the public hearing and the
- 5 agency shall make copies available to the public at the public
- 6 hearing. The agency shall publish the regulatory impact statement
- 7 on its website at least 10 days before the date of the public
- 8 hearing.
- 9 (5) The committee shall electronically transmit to the senate
- 10 fiscal agency and the house fiscal agency a copy of each rule and

- 23 is promulgated under section 33 or 48 or a rule to which sections
- 24 41 and 42 do not apply as provided in section 44.
