## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 6. (1) A person shall not engage in aquaculture unless he

- or she obtains a registration from the department as an aquaculture facility, obtains an aquaculture research permit, or unless otherwise exempt by rule or law. If the activity in which the aquaculture facility is engaged is required to be regulated under any act, registration under this act does not exempt the person or aquaculture facility from requirements imposed under any local, state, or federal regulation.
  - (2) The following are exempt from registration as an aquaculture facility:
    - (a) Retail bait outlets.

- 16 (4) An aquaculture facility in existence before January 1,

- 19 aquaculture. Any person engaging in aquaculture beginning on or
- 20 after January 1, 1997 is required to obtain a registration or
- 21 permit under this act, or both, if applicable, in order to engage
- 22 in aquaculture.
- 23 Sec. 8. (1) Research of an aquaculture species not on the
- 24 approved list is allowed and shall be conducted pursuant to an
- 25 aquaculture research permit in a confinement research facility.
- 26 (2) A person who holds an aquaculture research permit shall
- 27 not import aquaculture species that are the subject of the research
