SUBSTITUTE FOR

HOUSE BILL NO. 6543

A bill to amend 1998 PA 58, entitled "Michigan liquor control code of 1998,"

(MCL 436.1101 to 436.2303) by adding section 1028.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 1028. (1) THE COMMISSION MAY ISSUE A SPECIAL LICENSE
- 2 UNDER THIS SECTION TO A QUALIFIED ORGANIZATION CONDUCTING A SPIRITS
- 3 TASTING. THE APPLICATION MUST CONFORM TO ALL OF THE FOLLOWING:
- 4 (A) BE SUBMITTED BY A QUALIFIED ORGANIZATION.
- 5 (B) THE SPIRITS TASTING INVOLVES AN EVENT HAVING FOR ITS
- 6 PRIMARY PURPOSE THE SHOWCASING OF SPIRITS AND THE SPIRITS'
- 7 PRODUCTION AND OR MIXABILITY.
- 8 (C) BE ACCOMPANIED BY A FEE OF \$25.00 PER DAY OF THE EVENT.
- 9 (2) THE HOLDER OF A SPECIAL LICENSE ISSUED UNDER THIS SECTION
- 10 SHALL NOT ALLOW MORE THAN 6 EVENTS PER CALENDAR YEAR CONFORMING TO

- 1 THE REQUIREMENTS OF SUBSECTION (1).
- 2 (3) A HOLDER OF A SPECIAL LICENSE ISSUED UNDER THIS SECTION
- 3 MAY PURCHASE THE SPIRITS FOR THE EVENT UNDER R 436.582 OF THE
- 4 MICHIGAN ADMINISTRATIVE CODE.
- 5 (4) A HOLDER OF A SPECIAL LICENSE ISSUED UNDER THIS SECTION
- 6 THAT DID NOT RECEIVE A DISCOUNT FROM A SPECIALLY DESIGNATED
- 7 DISTRIBUTOR FOR THE PURCHASE OF SPIRITS UNDER SECTION 609D(1) MAY
- 8 RECEIVE A REBATE ON THE PURCHASE OF SPIRITS SUBJECT TO ALL OF THE
- 9 FOLLOWING:
- 10 (A) THE REBATE MUST BE THE DIFFERENCE OF THE PURCHASE PRICE
- 11 THE SPECIAL LICENSEE PAID TO THE SPECIALLY DESIGNATED DISTRIBUTOR
- 12 AND THE SUM OF THE FOLLOWING:
- 13 (i) THE PRICE THE COMMISSION PAID FOR THE SPIRITS BEFORE
- 14 ESTABLISHING THE PRICE TO DETERMINE THE GROSS PROFIT UNDER SECTION
- 15 233.
- 16 (ii) FIFTEEN PERCENT OF THE PRICE UNDER SUBPARAGRAPH (i).
- 17 (iii) SPECIFIC TAXES CALCULATED ON THE PRICE OF THE SPIRITS
- 18 ESTABLISHED UNDER SECTION 233.
- 19 (B) THE SPECIAL LICENSEE SHALL SUBMIT 1 COMBINED REQUEST FOR A
- 20 REBATE BY MARCH 1 OF EACH YEAR FOR ALL SPIRIT TASTING EVENTS FOR
- 21 WHICH IT WAS ISSUED A SPECIAL LICENSE UNDER THIS SECTION IN THE
- 22 PREVIOUS CALENDAR YEAR.
- 23 (C) THE SPECIAL LICENSEE SHALL SUBMIT ITS REQUEST FOR A REBATE
- 24 ON A FORM PRESCRIBED BY THE COMMISSION. THE SPECIAL LICENSEE SHALL
- 25 INCLUDE ALL OF THE FOLLOWING INFORMATION WITH ITS REQUEST FOR A
- 26 REBATE:
- 27 (i) THE DATE OR DATES OF THE SPIRITS TASTING EVENTS FOR WHICH

- 1 A REBATE IS BEING REQUESTED.
- 2 (ii) THE NAME AND LICENSE NUMBER OF THE SPECIALLY DESIGNATED
- 3 DISTRIBUTOR FROM WHICH THE SPIRITS WERE PURCHASED.
- 4 (iii) THE PURCHASE PRICE PAID PER BOTTLE TO THE SPECIALLY
- 5 DESIGNATED DISTRIBUTOR.
- 6 (iv) THE QUANTITY OF BOTTLES PURCHASED LESS ANY BOTTLES
- 7 RETURNED UNDER SECTION 609D(2).
- 8 (v) THE SPECIAL LICENSEE SHALL SUBMIT A COPY OF THE RECEIPT OR
- 9 INVOICE THAT SHOWS THE PRICE IT PAID FOR THE SPIRITS TO THE
- 10 SPECIALLY DESIGNATED DISTRIBUTOR AND ANY PRODUCTS RETURNED UNDER
- 11 SECTION 609D(2).
- 12 (D) BY JUNE OF EACH YEAR, THE COMMISSION SHALL ISSUE A
- 13 COMBINED REBATE TO THE SPECIAL LICENSEE FOR EACH OF THE EVENTS IN
- 14 THE PREVIOUS CALENDAR YEAR FOR WHICH THE SPECIAL LICENSEE SUBMITTED
- 15 A REQUEST FOR A REBATE.
- 16 (5) A HOLDER OF A SPECIAL LICENSE ISSUED UNDER THIS SECTION
- 17 AND THE MEMBER VENDORS OF SPIRITS, SMALL DISTILLERS, AUTHORIZED
- 18 DISTRIBUTION AGENTS, AND BROKERS WHOSE VENDOR REPRESENTATIVES,
- 19 SALESPERSONS, OR AGENTS ARE LICENSED BY THE COMMISSION, MAY POUR
- 20 AND SERVE SPIRITS, WITH OR WITHOUT MIXERS.
- 21 (6) AS USED IN THIS SECTION:
- 22 (A) "QUALIFIED ORGANIZATION" IS A NONPROFIT ASSOCIATION WHOSE
- 23 MEMBERSHIP INCLUDES AT LEAST 15 PRIMARY MEMBERS AND CONSISTS OF AT
- 24 LEAST 3 OF THE FOLLOWING THAT ARE LICENSED BY THE COMMISSION:
- 25 (i) VENDORS OF SPIRITS.
- 26 (ii) SMALL DISTILLERS.
- 27 (iii) BROKERS. AS USED IN THIS SUBPARAGRAPH, "BROKER" MEANS

- 1 THAT TERM AS DEFINED IN SECTION 609.
- 2 (iv) AUTHORIZED DISTRIBUTION AGENTS.
- (B) "SPIRITS TASTING" MEANS AN EVENT AT WHICH SPIRITS ARE 3
- 4 SHOWCASED TO THE GENERAL PUBLIC AND AT WHICH THE GENERAL PUBLIC CAN
- PURCHASE AND SAMPLE THE SPIRITS BEING SHOWCASED FOR CONSUMPTION ON 5
- THE LICENSED PREMISES.
- 7 Enacting section 1. This amendatory act does not take effect
- unless Senate Bill No. 1181 of the 99th Legislature is enacted into 8
- 9 law.
