SUBSTITUTE FOR

SENATE BILL NO. 842

A bill to amend 1978 PA 368, entitled "Public health code,"

by amending section 17766 (MCL 333.17766), as amended by 2006 PA 416 , and by adding sections 7423 and 21418 .

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 7423. THE DELIVERY OF A CONTROLLED SUBSTANCE UNDER
- 2 SECTION 21418 FOR THE PURPOSE OF DISPOSING OF THE CONTROLLED
- 3 SUBSTANCE IS NOT A VIOLATION OF THIS ARTICLE.
- 4 Sec. 17766. Except as provided in sections 17766d, and 17780,
- 5 AND 21418, a person who—THAT does any of the following is guilty of
- 6 a misdemeanor:
- 7 (a) Obtains or attempts to obtain a prescription drug by
- 8 giving a false name to a pharmacist or other authorized seller,

- 1 prescriber, or dispenser.
- 2 (b) Obtains or attempts to obtain a prescription drug by
- 3 falsely representing that he or she is a lawful prescriber,
- 4 dispenser, or licensee, or acting on behalf of a lawful prescriber,
- 5 dispenser, or licensee.
- 6 (c) Falsely makes, utters, publishes, passes, alters, or
- 7 forges a prescription.
- 8 (d) Knowingly possesses a false, forged, or altered
- 9 prescription.
- 10 (e) Knowingly attempts to obtain, obtains, or possesses a drug
- 11 by means of a prescription for other than a legitimate therapeutic
- 12 purpose, or as a result of a false, forged, or altered
- 13 prescription.
- 14 (f) Possesses or controls for the purpose of resale, or sells,
- 15 offers to sell, dispenses, or gives away, a drug, pharmaceutical
- 16 preparation, or chemical that has been dispensed on prescription
- 17 and has left the control of a pharmacist.
- 18 (g) Possesses or controls for the purpose of resale, or sells,
- 19 offers to sell, dispenses, or gives away, a drug, pharmaceutical
- 20 preparation, or chemical that has been damaged by heat, smoke,
- 21 fire, water, or other cause and is unfit for human or animal use.
- 22 (h) Prepares or permits the preparation of a prescription
- 23 drug, except as delegated by a pharmacist.
- 24 (i) Sells a drug in bulk or in an open package at auction,
- 25 unless the sale has been approved in accordance with rules of the
- 26 board.
- 27 SEC. 21418. (1) BEGINNING 90 DAYS AFTER THE DEPARTMENT

- 1 PROMULGATES RULES TO IMPLEMENT THIS SECTION, A HOSPICE OR HOSPICE
- 2 RESIDENCE THAT PROVIDES SERVICES IN A PATIENT'S PRIVATE HOME SHALL
- 3 ESTABLISH AND IMPLEMENT A WRITTEN CONTROLLED SUBSTANCE DISPOSAL
- 4 POLICY ESTABLISHING PROCEDURES TO BE FOLLOWED TO MITIGATE THE
- 5 DIVERSION OF CONTROLLED SUBSTANCES THAT ARE PRESCRIBED TO THE
- 6 PATIENT. THE POLICY MUST INCLUDE ALL OF THE FOLLOWING:
- 7 (A) A PROCEDURE FOR OFFERING TO ASSIST WITH THE DISPOSAL OF A
- 8 CONTROLLED SUBSTANCE THAT IS PRESCRIBED TO A PATIENT AS PART OF THE
- 9 PATIENT'S HOSPICE PLAN OF CARE.
- 10 (B) A REQUIREMENT THAT AN EMPLOYEE PROVIDE THE PATIENT OR THE
- 11 PATIENT'S FAMILY EDUCATION ON SAFE DISPOSAL LOCATIONS FOR A
- 12 CONTROLLED SUBSTANCE AND TECHNIQUES FOR THE SAFE DISPOSAL OF A
- 13 CONTROLLED SUBSTANCE WHEN THE CONTROLLED SUBSTANCE IS NO LONGER
- 14 NEEDED BY THE PATIENT OR AT THE TIME OF DEATH.
- 15 (C) PROCEDURES FOR OFFERING ASSISTANCE WITH THE DISPOSAL OF A
- 16 CONTROLLED SUBSTANCE TO A PATIENT WHO REVOKES HOSPICE CARE AND
- 17 SERVICES.
- 18 (D) A REQUIREMENT THAT AN EMPLOYEE DOCUMENT WHETHER THE
- 19 PATIENT OR THE PATIENT'S FAMILY ACCEPTED OR REFUSED AN OFFER TO
- 20 ASSIST WITH THE DISPOSAL OF A CONTROLLED SUBSTANCE WHEN THE
- 21 CONTROLLED SUBSTANCE IS NO LONGER NEEDED BY THE PATIENT OR AT THE
- 22 TIME OF DEATH.
- 23 (E) A REQUIREMENT THAT IF AN EMPLOYEE ASSISTS WITH THE
- 24 DISPOSAL OF A CONTROLLED SUBSTANCE, THE DISPOSAL IS PERFORMED AND
- 25 WITNESSED IN ANY OF THE FOLLOWING WAYS:
- 26 (i) PERFORMED BY THE EMPLOYEE AND WITNESSED BY ANOTHER
- 27 COMPETENT ADULT.

- 1 (ii) PERFORMED BY THE PATIENT OR THE PATIENT'S FAMILY AND
- 2 WITNESSED BY ANOTHER COMPETENT ADULT.
- 3 (F) A REQUIREMENT THAT IF AN EMPLOYEE ASSISTS WITH THE
- 4 DISPOSAL OF A CONTROLLED SUBSTANCE, THE DISPOSAL MUST BE PERFORMED
- 5 IN THE PATIENT'S PRIVATE HOME.
- 6 (2) A HOSPICE OR HOSPICE RESIDENCE THAT PROVIDES SERVICES IN A
- 7 PATIENT'S PRIVATE HOME SHALL ENSURE THAT ALL OF THE FOLLOWING ARE
- 8 MET WITHIN 5 DAYS OF ADMISSION TO THE HOSPICE OR HOSPICE RESIDENCE
- 9 AND PROVIDING HOSPICE CARE OR SERVICES TO THE PATIENT IN THE
- 10 PATIENT'S PRIVATE HOME:
- 11 (A) THAT A COPY OF THE CONTROLLED SUBSTANCE DISPOSAL POLICY
- 12 ESTABLISHED UNDER SUBSECTION (1) IS DISTRIBUTED TO THE PATIENT OR
- 13 THE PATIENT'S FAMILY AND THAT AN OFFER TO DISCUSS THE PROCEDURES
- 14 INCLUDED IN THE POLICY IS MADE TO THE PATIENT AND THE PATIENT'S
- 15 FAMILY.
- 16 (B) THAT THE PATIENT AND THE PATIENT'S FAMILY ARE INFORMED
- 17 THAT AN EMPLOYEE WILL OFFER TO ASSIST WITH THE DISPOSAL OF A
- 18 CONTROLLED SUBSTANCE THAT IS INCLUDED IN THE PATIENT'S HOSPICE PLAN
- 19 OF CARE AT THE TIME OF DEATH OR WHEN THE CONTROLLED SUBSTANCE IS NO
- 20 LONGER NEEDED BY THE PATIENT.
- 21 (3) THE DEPARTMENT SHALL PROMULGATE RULES TO IMPLEMENT THIS
- 22 SECTION, INCLUDING, BUT NOT LIMITED TO, RULES GOVERNING THE SAFE
- 23 DISPOSAL OF CONTROLLED SUBSTANCES IN A PATIENT'S PRIVATE HOME.
- 24 (4) AS USED IN THIS SECTION:
- 25 (A) "AT THE TIME OF DEATH" MEANS WITHIN 72 HOURS AFTER THE
- 26 PATIENT'S DEATH.
- 27 (B) "EMPLOYEE" MEANS A REGISTERED PROFESSIONAL NURSE OR

- 1 LICENSED PRACTICAL NURSE WHO IS EMPLOYED BY THE HOSPICE OR HOSPICE
- 2 RESIDENCE.
- (C) "LICENSED PRACTICAL NURSE" MEANS AN INDIVIDUAL WHO IS 3
- LICENSED TO ENGAGE IN THE PRACTICE OF NURSING AS A LICENSED
- 5 PRACTICAL NURSE UNDER ARTICLE 15.
- (D) "PATIENT'S FAMILY" MEANS A RELATIVE OR CAREGIVER WHO HAS 6
- 7 BEEN DESIGNATED BY THE PATIENT.
- (E) "PATIENT'S PRIVATE HOME" MEANS A PATIENT'S HOME. AS USED 8
- IN THIS SUBDIVISION, "HOME" DOES NOT INCLUDE A RESIDENCE 9
- 10 ESTABLISHED BY A PATIENT IN A HEALTH FACILITY OR AGENCY OR A
- 11 RESIDENCE ESTABLISHED BY A PATIENT IN AN ADULT FOSTER CARE FACILITY
- 12 LICENSED UNDER THE ADULT FOSTER CARE FACILITY LICENSING ACT, 1979
- PA 218, MCL 400.701 TO 400.737. 13
- (F) "REGISTERED PROFESSIONAL NURSE" MEANS THAT TERM AS DEFINED 14
- IN SECTION 17201. 15
- 16 Enacting section 1. This amendatory act takes effect 90 days
- 17 after the date it is enacted into law.
