## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 517a. (1) The commission may issue national sporting
 event licenses for the sale of alcoholic liquor for consumption on
 the premises concerning a national sporting event, if the
 commission finds all of the following circumstances exist:

5 (a) The local governmental unit in which the national sporting
6 event is to be conducted is the host governmental unit for the
7 national sporting event.

governmental unit in connection with the national sporting event or
 are operated in conjunction with the national sporting event.

3 (c) The commission determines that the national sporting event
4 will attract a substantial number of tourists from outside this

6 (d) The national sporting event is conducted under the7 auspices of a national sanctioning body.

(e) The applicant is any of the following:

9 (i) A Michigan licensee for the sale of alcoholic liquor for10 consumption on the premises.

11 (*ii*) The promoter of the national sporting event or an12 affiliate of the promoter.

13 (iii) A person who has entered into a written concession or 14 catering agreement with the promoter of the national sporting event 15 or its affiliate, which agreement has been approved by the 16 commission.

17 (*iv*) An organization qualified for licensure as a special
18 licensee under section 111(11) 111(13) and the rules of the
19 commission.

(2) A license issued under this section must be for a period
of not more than 30 consecutive days and is not transferable as to
ownership or location. The license must be for specific designated
time periods that include the national sporting event and
activities associated with the national sporting event.
