## **SENATE BILL No. 1167**

November 8, 2018, Introduced by Senator WARREN and referred to the Committee on Regulatory Reform.

A bill to amend 1998 PA 58, entitled "Michigan liquor control code of 1998," by amending section 113a (MCL 436.1113a), as amended by 2010 PA 213.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 113a. (1) "TASTING ROOM" MEANS ANY OF THE FOLLOWING
- 2 LOCATIONS:
- 3 (A) A LOCATION ON THE MANUFACTURING PREMISES OF A BREWER OR
- 4 MICRO BREWER WHERE THE BREWER OR MICRO BREWER MAY PROVIDE SAMPLES
- 5 OF OR SELL AT RETAIL FOR CONSUMPTION ON OR OFF THE PREMISES, OR
- 6 BOTH, BEER IT MANUFACTURES.
- 7 (B) A LOCATION ON OR OFF THE MANUFACTURING PREMISES OF A WINE
- 8 MAKER OR SMALL WINE MAKER WHERE THE WINE MAKER OR SMALL WINE MAKER
  - MAY PROVIDE SAMPLES OF OR SELL AT RETAIL FOR CONSUMPTION ON OR OFF

- 1 THE PREMISES, OR BOTH, SHINERS, WINE IT MANUFACTURED, OR, FOR A

- 3 (C) A LOCATION ON OR OFF THE MANUFACTURING PREMISES OF A
- 4 DISTILLER OR SMALL DISTILLER WHERE THE DISTILLER OR SMALL DISTILLER
- 5 MAY PROVIDE SAMPLES OF OR SELL AT RETAIL FOR CONSUMPTION ON OR OFF
- 6 THE PREMISES, OR BOTH, SPIRITS IT MANUFACTURED.
- 7 (D) A LOCATION ON THE MANUFACTURING PREMISES OF A MIXED SPIRIT
- 8 DRINK MANUFACTURER WHERE THE MIXED SPIRIT DRINK MANUFACTURER MAY
- 9 PROVIDE SAMPLES OF OR SELL AT RETAIL FOR CONSUMPTION ON OR OFF THE
- 10 PREMISES, OR BOTH, MIXED SPIRIT DRINKS IT MANUFACTURED.
- 11 (E) A LOCATION ON OF OFF THE MANUFACTURING PREMISES OF A
- 12 BRANDY MANUFACTURER WHERE THE BRANDY MANUFACTURER MAY PROVIDE
- 13 SAMPLES OF OR SELL AT RETAIL FOR CONSUMPTION ON OR OFF THE
- 14 PREMISES, OR BOTH, BRANDY IT MANUFACTURED.
- (2) (1)—"Tavern" means any place licensed to sell at retail
- 16 beer and wine for consumption on the premises only.
- 17 (3) (2) "Vehicle" means any means of transportation by land,
- 18 by water, or by air.
- 19 (4)  $\frac{(3)}{}$  "Vendor" means a person licensed by the commission to
- 20 sell alcoholic liquor.
- 21 (5) (4)—"Vendor of spirits" means a person selling spirits to
- 22 the commission.
- 23 (6) (5)—"Warehouse" means a premises or place primarily
- 24 constructed, used, or provided with facilities for the storage in
- 25 transit or other temporary storage of perishable goods or for the
- 26 conduct of a warehousing business, or for both.
- 27 (7) (6) "Warehouser" means a licensee authorized by the

- 1 commission to store alcoholic liquor, but prohibited from making
- 2 sales or deliveries to retailers unless the licensee is also the
- 3 holder of a wholesaler license issued by the commission.
- 4 (8) (7) "Wholesaler" means a person who is licensed by the
- 5 commission and sells beer, wine, or mixed spirit drink only to
- 6 retailers or other licensees, and who sells sacramental wine as
- 7 provided in section 301. A wholesaler includes a person who may
- 8 also act as a master distributor unless prohibited from doing so by
- 9 its supplier or manufacturer in a written agreement required by
- 10 either section 305(3)(i) or 403(3)(i) and, by mutual agreement with
- 11 an outstate seller of beer or wine, can be authorized by the
- 12 outstate seller of beer or wine to do, in the manner provided by
- 13 the commission, either or both of the following:
- 14 (a) Register with the THIS state of Michigan the labels of the
- 15 outstate seller of beer or wine.
- 16 (b) On behalf of the outstate seller of beer or wine, collect
- 17 excise taxes levied by the THIS state of Michigan and remit the
- 18 taxes to the commission.
- 19 (9) <del>(8)</del> "Wine" means the product made by the normal alcoholic
- 20 fermentation of the juice of sound, ripe grapes, or any other fruit
- 21 with the usual cellar treatment, and containing not more than 21%
- 22 of alcohol by volume, including CIDER MADE FROM APPLES OR PEARS, OR
- 23 BOTH, WHICH CONTAINS AT LEAST 1/2 OF 1% ALCOHOL BY VOLUME, OR MEAD
- 24 OR HONEY WINE MADE FROM HONEY, fermented fruit juices other than
- 25 grapes, and mixed wine drinks.
- 26 (10) <del>(9)</del> "Wine maker" means any person licensed by the
- 27 commission to manufacture wine, to sell that wine to a wholesaler,

- 1 to sell that wine by direct shipment to a consumer, at retail on
- 2 the licensed winery premises, and as provided for in section 537
- 3 but not to sell wine to a retailer.
- 4 Enacting section 1. This amendatory act does not take effect
- 5 unless Senate Bill No. 1156
- of the 99th Legislature is enacted into law.
