A bill to amend 2018 PA 338, entitled

by amending the title and sections 1, 2, 3, 4, 5, 7, 8, 10, 11, and

408.968, 408.970, 408.971, and 408.974); and to repeal acts and
parts of acts.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

TITLE

An initiation of legislation ACT to REQUIRE CERTAIN EMPLOYERS

TO provide workers CERTAIN EMPLOYEES with the right to earn sick

time PAID MEDICAL LEAVE for personal or family health needs, as

well as purposes related to domestic violence and sexual assault;

and school meetings needed as the result of a child's disability,

- 12 BY AN EMPLOYER TO CALCULATE AN ELIGIBLE EMPLOYEE'S BENEFITS.
- (B) (a)—"Department" means the department of licensing and
- 14 regulatory affairs.
- 15 (C) (b) "Director" means the director of the department of
- 16 licensing and regulatory affairs or his or her THE DIRECTOR'S
- 17 designee.
- 18 (c) "Domestic partner" means an adult in a committed
- 19 relationship with another adult, including both same sex and
- 20 different-sex relationships. "Committed relationship" means one in
- 21 which the employee and another individual share responsibility for
- 22 a significant measure of each other's common welfare, such as any
- 23 relationship between individuals of the same or different sex that
- 24 is granted legal recognition by a state, political subdivision, or
- 25 the District of Columbia as a marriage or analogous relationship,
- 26 including, but not limited to, a civil union.
- 27 (d) "Domestic violence" has the same meaning MEANS THAT TERM

- 2 (e) "Earned sick time" means time off from work that is
- 3 provided by an employer to an employee, whether paid or unpaid,
- 4 that can be used for the purposes described in subsection (1) of
- 5 section 4 of this act.
- 6 (E) (f) "Employee" "ELIGIBLE EMPLOYEE" means an individual
- 7 engaged in service to an employer in the business of the employer,
- 8 except that employee does not include an individual employed by the
- 9 United States government. THAT TERM AS DEFINED IN SECTION 101 OF THE
- 10 FAMILY AND MEDICAL LEAVE ACT, 29 USC 2611, AND FROM WHOM AN

- 2 (vii) AN INDIVIDUAL WHOSE PRIMARY WORK LOCATION IS NOT IN THIS
- 3 STATE.
- 4 (viii) AN INDIVIDUAL WHOSE MINIMUM HOURLY WAGE RATE IS
- 5 DETERMINED UNDER SECTION 4B OF THE IMPROVED WORKFORCE OPPORTUNITY
- 6 WAGE ACT, 2018 PA 337, MCL 408.934B.
- 7 (ix) AN INDIVIDUAL DESCRIBED IN SECTION 29(1)(l) OF THE
- 8 MICHIGAN EMPLOYMENT SECURITY ACT, 1936 (EX SESS) PA 1, MCL 421.29.
- 9 (F) (g) "Employer" means any person, firm, business,
- 10 educational institution, nonprofit agency, corporation, limited
- 11 liability company, government entity, or other entity that employs
- 12 1 or more individuals, except that employer does not include the
- 13 United States government. THAT TERM AS DEFINED IN SECTION 101 OF THE
- 14 FAMILY AND MEDICAL LEAVE ACT, 29 USC 2611. EMPLOYER DOES NOT

- 26 FOR THE PURPOSES DESCRIBED IN SECTION 4(1).
- 27 (J) (k) "Sexual assault" means any act that constitutes a

- 2 of the Michigan penal code, 1931 PA 328, MCL 750.520b, 750.520c,

- 5 individuals work for compensation during a given week. In
- 6 determining the number of individuals performing work for

- 14 PAID FAMILY MEDICAL LEAVE IN A SINGLE BENEFIT YEAR.
- 15 (3) AS AN ALTERNATIVE TO SUBSECTION (2), AN EMPLOYER MAY
- 16 PROVIDE AT LEAST 36 HOURS OF PAID MEDICAL LEAVE TO AN ELIGIBLE
- 17 EMPLOYEE AT THE BEGINNING OF A BENEFIT YEAR OR ON THE DATE THE
- 18 INDIVIDUAL BECOMES AN ELIGIBLE EMPLOYEE. IF AN EMPLOYER ELECTS TO
- 19 PROVIDE PAID MEDICAL LEAVE TO AN ELIGIBLE EMPLOYEE PURSUANT TO THIS

- 2 (2) Earned sick time as provided in this section shall begin

- 3 to accrue on the effective date of this law, or upon commencement
- 4 of the employee's employment, whichever is later. An employee may
- 5 use accrued earned sick time as it is accrued, except that an
- 6 employer may require an employee hired after April 1, 2019, to wait
- 7 until the ninetieth calendar day after commencing employment before
- 8 using accrued earned sick time.
- 9 (3) For purposes of subsection (1), "year" shall mean a
- 10 regular and consecutive twelve month period, as determined by an

- 18 (4) (5) An THERE IS A REBUTTABLE PRESUMPTION THAT AN employer
- 19 other than an small business is in compliance with this section ACT
- 20 if the employer provides any paid leave in at least the same
- 21 amounts as that provided under this act that may be used for the
- 22 same purposes and under the same conditions provided in this act
- 23 and that is accrued at a rate equal to or greater than the rate
- 24 described in subsections (1) and (2). An employer that is a small
- 25 business is in compliance with this section if the employer
- 26 provides paid leave in at least the same amounts as that provided

- 9 (5) (6) An employer shall pay each **ELIGIBLE** employee using
- 10 paid earned sick time MEDICAL LEAVE at a pay rate equal to the
- 11 greater of either the normal hourly wage OR BASE WAGE for that
- 12 ELIGIBLE employee or the APPLICABLE minimum wage RATE established
- 13 under the IMPROVED workforce opportunity wage act, 2014 PA 138, MCL
- 14 408.411 to 408.424, but not less than the minimum wage rate
- 15 established in section 4 of the workforce opportunity wage act,
- 16 2014, PA 138, MCL 408.414. For any employee whose hourly wage
- 17 varies depending on the work performed, the "normal hourly wage"
- 18 means the average hourly wage of the employee in the pay period
- 19 immediately prior to the pay period in which the employee used paid
- 20 earned sick time.
- 21 (7) An employer shall not require an employee to search for or
- 22 secure a replacement worker as a condition for using earned sick

- 24 REQUIRED TO INCLUDE OVERTIME PAY, HOLIDAY PAY, BONUSES,
- 25 COMMISSIONS, SUPPLEMENTAL PAY, PIECE-RATE PAY, OR GRATUITIES IN THE
- 26 CALCULATION OF AN ELIGIBLE EMPLOYEE'S NORMAL HOURLY WAGE OR BASE

- 7 public health emergency; for an **ELIGIBLE** employee's need to care

- 10 it has been determined by the health authorities having

- 21 the earned sick time is not foreseeable, an employer may require
- 22 the employee to give notice of the intention as soon as
- 23 practicable.AN ELIGIBLE EMPLOYEE SHALL, WHEN REQUESTING TO USE PAID
- 24 MEDICAL LEAVE, COMPLY WITH HIS OR HER EMPLOYER'S USUAL AND
- 25 CUSTOMARY NOTICE, PROCEDURAL, AND DOCUMENTATION REQUIREMENTS FOR

- 5 (c) a-A court document indicating that the ELIGIBLE employee or **ELIGIBLE** employee's family member is involved in legal action 6 related to domestic violence or sexual assault. An employer shall 7 not require that the documentation explain the nature of the 8 9 illness or the details of the violence. If an employer chooses to 10 require documentation for earned sick time, the employer is 11 responsible for paying all out-of-pocket expenses the employee 12 incurs in obtaining the documentation. If the employee does have 13 health insurance, the employer is responsible for paying any costs 14 charged to the employee by the health care provider for providing the specific documentation required by the employer. 15
- (5) AN EMPLOYER SHALL NOT REQUIRE THAT THE DOCUMENTATION 16 17 PROVIDED UNDER SUBSECTION (4) EXPLAIN THE DETAILS OF THE VIOLENCE. 18 An employer shall not require disclosure of details relating to 19 domestic violence or sexual assault or the details of an ELIGIBLE 20 employee's or an **ELIGIBLE** employee's family member's medical 21 condition as a condition of providing earned sick time PAID MEDICAL 22 **LEAVE** under this act. If an employer possesses health information 23 or information pertaining to domestic violence or sexual assault 24 about an ELIGIBLE employee or ELIGIBLE employee's family member, 25 the employer shall treat that information as confidential and shall 26 not disclose that information except to the affected ELIGIBLE

employee or with the permission of the affected ELIGIBLE employee.

- 1 (6) This act does not require an employer to provide earned
- 2 sick time PAID MEDICAL LEAVE for any purposes other than as
- 3 described in this section.
- 4 Sec. 5. (1) If an **ELIGIBLE** employee is transferred to a
- 5 separate division, entity, or location, but remains employed by the
- 6 same employer, the **ELIGIBLE** employee shall retain **RETAINS** all
- 7 earned sick time PAID MEDICAL LEAVE that was accrued at the prior
- 8 division, entity, or location and may use all THE accrued earned
- 9 sick time as provided in PAID MEDICAL LEAVE PURSUANT TO section 4.
- 10 If an **ELIGIBLE** employee separates from employment and is rehired by
- 11 the same employer, within 6 months of the separation, the employer
- 12 shall reinstate previously accrued, IS NOT REQUIRED TO ALLOW THE

- 24 (2) (3) This act does not require an employer to provide
- 25 financial or other reimbursement to an **ELIGIBLE** employee for
- 26 accrued earned sick time PAID MEDICAL LEAVE that was not used upon
- 27 BEFORE the employee's END OF A BENEFIT YEAR OR BEFORE THE ELIGIBLE

- ${f 1}$ **EMPLOYEE'S** termination, resignation, retirement, or other
- 2 separation from employment.
- 3 Sec. 7. (1) If an employer violates this act, the **ELIGIBLE**
- 4 employee affected by the violation, at any time within 3 years 6
- 5 MONTHS after the violation or the date when the employee knew of
- 6 the violation, whichever is later, may do any of the following:
- 7 (a) Bring a civil action for appropriate relief, including,
- 8 but not limited to, payment for used earned sick time; rehiring or
- 9 reinstatement to the employee's previous job; payment of back
- 10 wages; reestablishment of employee benefits to which the employee
- 11 otherwise would have been eligible if the employee had not been
- 12 subjected to retaliatory personnel action or discrimination; and an
- 13 equal additional amount as liquidated damages together with costs
- 14 and reasonable attorney fees as the court allows.
- 15 (b) File MAY FILE a claim with the department. , which shall
- 16 investigate the claim. Filing a claim with the department is
- 17 neither a prerequisite nor a bar to bringing a civil action.
- 18 (2) (a) The director shall enforce the provisions of this act.
- 19 In effectuating such enforcement, the THE director shall establish
- 20 a system utilizing multiple means of communication to receive
- 21 complaints regarding non-compliance with this act and investigate
- 22 complaints received by the department in a timely manner.
- 23 (b) Any person alleging a violation of this chapter shall have
- 24 the right to file a complaint with the department. The department
- 25 shall encourage reporting pursuant to this subsection by keeping
- 26 confidential, to the maximum extent permitted by applicable laws,
- 27 the name and other identifying information of the employee or

- 1 person reporting the violation, provided, however, that with the
- 2 authorization of such person, the department may disclose his or
- 3 her name and identifying information as necessary to enforce this
- 4 chapter or for other appropriate purposes.
- 5 (3) (c) Upon receiving a complaint alleging a violation of
- 6 this chapter, ACT, the department shall investigate such THE
- 7 complaint and attempt to resolve it through mediation between the
- 8 complainant and the subject of the complaint, or other means. The
- 9 department shall keep complainants notified regarding the status of
- 10 their complaint and any resultant investigation. If the department
- 11 believes DETERMINES that a violation has occurred, it shall issue
- 12 to the offending person or entity a notice of violation and the
- 13 relief required of the offending person. or entity. The department
- 14 shall prescribe the form and wording of such notices of violation,
- 15 including any WHICH MUST INCLUDE THE method of appealing the
- 16 decision DETERMINATION of the department.
- 17 (4) (d) The department shall have the power to MAY impose
- 18 penalties and to-grant an ELIGIBLE employee or former ELIGIBLE
- 19 employee all appropriate relief including but not limited to
- 20 payment of all earned sick time PAID MEDICAL LEAVE improperly
- 21 withheld. , any and all damages incurred by the complainant as the
- 22 result of violation of this act, back pay and reinstatement in the
- 23 case of job loss.
- 24 (3) If the director determines that there is reasonable cause
- 25 to believe that an employer violated this act and the department is
- 26 subsequently unable to obtain voluntary compliance by the employer
- 27 within a reasonable time, the department shall bring a civil action

- 1 as provided in subsection (1)(a) on behalf of the employee. The
- 2 department may investigate and file a civil action under subsection
- 3 (1)(a) on behalf of all employees that employer who are similarly
- 4 situated at the same work site and who have not brought a civil
- 5 action under subsection (1)(a). A contract or agreement between the
- 6 employer and the employee or any acceptance by the employee of a
- 7 paid or unpaid leave policy that provides fewer rights or benefits
- 8 than provided by this act is void and unenforceable.
- 9 (5) (4) In addition to liability for civil remedies described
- 10 in this section, an AN employer who THAT fails to provide earned
- 11 sick time PAID MEDICAL LEAVE in violation of this act or takes
- 12 retaliatory personnel action against an employee or former employee
- 13 is subject to a civil AN ADMINISTRATIVE fine of not more than
- **14** \$1,000.00.
- 15 (6) (5)—An employer that willfully violates a notice or THE
- 16 posting requirement of section 8 is subject to a civil AN
- 17 ADMINISTRATIVE fine of not more than \$100.00 for each separate
- 18 violation.
- 19 Sec. 8. (1) An employer subject to this act shall provide
- 20 written notice to each employee at the time of hiring or by April
- 21 1, 2019, whichever is later, including, but not limited to, DISPLAY
- 22 A POSTER AT THE EMPLOYER'S PLACE OF BUSINESS, IN A CONSPICUOUS
- 23 PLACE THAT IS ACCESSIBLE TO ELIGIBLE EMPLOYEES, THAT CONTAINS all
- 24 of the following INFORMATION:
- 25 (a) The amount of earned sick time PAID MEDICAL LEAVE required
- 26 to be provided to an **ELIGIBLE** employee under this act.
- 27 (b) The employer's choice of how to calculate a "year"

- 1 according to subsection 3 of section 3.
- 2 (B) (c) The terms under which earned sick time PAID MEDICAL

- 3 **LEAVE** may be used.
- 4 (d) That retaliatory personnel action by the employer against
- 5 an employee for requesting or using earned sick time for which the
- 6 employee is eligible is prohibited.
- 7 (C) (e) The **ELIGIBLE** employee's right to bring a civil action
- 8 or file a complaint with the department for any violation of this
- 9 act.
- 10 (2) The notice required under subsection (1) shall be in
- 11 English, Spanish, and any language that is the first language
- 12 spoken by at least 10% of the employer's workforce, as long as the
- 13 department has translated the notice into such language.
- 14 (3) An employer shall display a poster at the employer's place
- of business, in a conspicuous place that is accessible to
- 16 employees, that contains the information in subsection (1). The
- 17 poster displayed should be in English, Spanish, and any language
- 18 that is the first language spoken by at least 10% of the employer's
- 19 workforce, as long as the department has translated the poster into
- 20 such language.
- 21 (2) $\frac{4}{}$ The department shall create and make available to
- 22 employers, notices and AT NO COST, posters that contain the
- 23 information required under subsection (1) for employers' use in
- 24 complying with this section. The department shall provide such
- 25 notices and posters in English, Spanish, and any other languages
- 26 deemed appropriate by the department.
- Sec. 10. An employer shall retain for not less than 3 years 1

- 1 YEAR records documenting the hours worked and earned sick time PAID
- 2 MEDICAL LEAVE taken by ELIGIBLE employees. To monitor compliance
- 3 with the requirements of this act, an employer shall allow the
- 4 department access to those records, with appropriate notice and at
- 5 a mutually agreeable time. If a question arises as to whether an
- 6 employer has violated an employee's right to earned sick time under
- 7 this act and the employer does not maintain or retain adequate
- 8 records documenting the hours worked and earned sick time taken by
- 9 the employee or does not allow the department reasonable access to
- 10 those records, there is a presumption that the employer has
- 11 violated the act, which can be rebutted only by clear and
- 12 convincing evidence.
- Sec. 11. (1) This act provides minimum requirements pertaining
- 14 to earned sick time and shall not be construed to preempt, limit,
- 15 or otherwise affect the applicability of any other law, regulation,
- 16 requirement, policy, or standard, including a collective bargaining
- 17 agreement, that provides for greater accrual or use of time off,
- 18 whether paid or unpaid, or that extends other protections to
- 19 employees.
- 20 (2) This act does not do any of the following:
- 21 (a) Prohibit an employer from providing more earned sick time
- 22 PAID MEDICAL LEAVE than is required under this act.
- 23 (b) Diminish any OTHER rights provided to any ELIGIBLE
- 24 employee under a collective bargaining agreement.
- 25 (c) Subject to section 12, preempt or override the terms of
- 26 any collective bargaining agreement in effect prior to the
- 27 effective date of this act.

- 1 (d) Prohibit an employer from establishing a policy that
- 2 permits an **ELIGIBLE** employee to donate unused accrued earned sick
- 3 time PAID MEDICAL LEAVE to another ELIGIBLE employee.
- 4 Sec. 14. If any portion of this act or the application thereof
- 5 to any person or circumstances shall be found to be invalid by a
- 6 court, such invalidity shall not affect, impair, or invalidate the
- 7 other portions or applications of the act that can be given effect
- 8 without the invalid portion or application, and to this end the
- 9 provisions of this act are declared to be severable. IF A FEDERAL
- 10 PAID MEDICAL LEAVE MANDATE IS ENACTED, THIS ACT DOES NOT APPLY AS
- 11 OF THE EFFECTIVE DATE OF THE MANDATE.
