## **HOUSE BILL No. 5123**

- 1 SEC. 8D. (1) THE DEPARTMENT SHALL PREPARE AND DISTRIBUTE TO EACH CHILD PLACED IN FOSTER CARE, AS AGE-APPROPRIATE, INFORMATION 2 3 DESCRIBING THE CHILDREN'S ASSURANCE OF QUALITY FOSTER CARE POLICY AND THE PROCESS TO FOLLOW IF THE CHILD IN FOSTER CARE HAS CONCERNS 5 REGARDING A VIOLATION OF THE CHILDREN'S ASSURANCE OF QUALITY FOSTER CARE POLICY. THIS INFORMATION SHALL INCLUDE INFORMATION REGARDING 6 7 THE CHILD IN FOSTER CARE'S CASEWORKER, LAWYER GUARDIAN AD LITEM, THE OFFICE OF THE CHILDREN'S OMBUDSMAN, THE DEPARTMENT'S OFFICE OF 9 FAMILY ADVOCATE, AND THE FOSTER CARE REVIEW BOARD.
