- 6 (v) MISUSE OF LEGAL DOCUMENTS TO DEPLETE THE ASSETS OF THE

- 8 DURABLE POWER OF ATTORNEY, A GUARDIANSHIP, OR A CONSERVATORSHIP.

- 11 (vii) A RECENTLY PURCHASED AUTOMOBILE BY THE VULNERABLE ADULT
- 12 OR ELDER ADULT THAT HE OR SHE DOES NOT DRIVE.
- 13 (viii) A NEW OR MISSING CREDIT CARD.
- 14 (ix) MISSING VALUABLES OR ANTIQUES.
- 15 (2) NOT LATER THAN 30 DAYS AFTER THE EFFECTIVE DATE OF THE
- 16 AMENDATORY ACT THAT ADDED THIS SECTION, THE DEPARTMENT OF THE
- 17 ATTORNEY GENERAL SHALL DEVELOP A STANDARD VULNERABLE ADULT/ELDER

- 5 (B) "ELDER ADULT" MEANS AN ADULT WHO IS 65 YEARS OF AGE OR
- 6 OLDER.
- 7 (C) "VULNERABLE ADULT" MEANS THAT TERM AS DEFINED IN SECTION
- 8 145M OF THE MICHIGAN PENAL CODE, 1931 PA 328, MCL 750.145M.
- 9 Enacting section 1. This amendatory act takes effect 90 days
- 10 after the date it is enacted into law.
