A bill to amend 1998 PA 58, entitled

"Michigan liquor control code of 1998,"

(MCL 436.1101 to 436.2303) by adding section 1028.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

SEC. 1028. (1) THE COMMISSION MAY ISSUE A SPECIAL LICENSE
 UNDER THIS SECTION TO A QUALIFIED ORGANIZATION CONDUCTING A SPIRITS
 TASTING. THE APPLICATION MUST CONFORM TO ALL OF THE FOLLOWING:

(A) BE SUBMITTED BY A QUALIFIED ORGANIZATION.

(B) THE SPIRITS TASTING INVOLVES AN EVENT HAVING FOR ITS PRIMARY PURPOSE THE SHOWCASING OF SPIRITS AND THE SPIRITS'

7 PRODUCTION AND OR MIXABILITY.

(C) BE ACCOMPANIED BY A FEE OF \$25.00 PER DAY OF THE EVENT.

9 (2) THE HOLDER OF A SPECIAL LICENSE ISSUED UNDER THIS SECTION 10 SHALL NOT ALLOW MORE THAN 6 EVENTS PER CALENDAR YEAR CONFORMING TO

2 (3) A HOLDER OF A SPECIAL LICENSE ISSUED UNDER THIS SECTION
3 MAY PURCHASE THE SPIRITS FOR THE EVENT BY EITHER OF THE FOLLOWING
4 METHODS:

5 (A) FROM ITS MEMBER VENDORS OF SPIRITS AND SMALL DISTILLERS AT 6 THE SAME PRICE QUOTED FOR SALE TO THE COMMISSION.

7 (B) AS A CONSOLIDATED TRANSACTION THROUGH 1 OR MORE AUTHORIZED
8 DISTRIBUTION AGENTS, AT THE SAME PRICE THAT THE COMMISSION WOULD

AND SERVE SPIRITS, WITH OR WITHOUT MIXERS.

17 (A) "QUALIFIED ORGANIZATION" IS A NONPROFIT ASSOCIATION WHOSE
18 MEMBERSHIP INCLUDES AT LEAST 15 PRIMARY MEMBERS AND CONSISTS OF ALL
19 OF THE FOLLOWING THAT ARE LICENSED BY THE COMMISSION:

20 (*i*) VENDORS OF SPIRITS.

21 (*ii*) SMALL DISTILLERS.

(*iii*) BROKERS. AS USED IN THIS SUBPARAGRAPH, "BROKER" MEANS
THAT TERM AS DEFINED IN SECTION 609.

24 (*iv*) AUTHORIZED DELIVERY AGENTS.

(B) "SPIRITS TASTING" MEANS AN EVENT AT WHICH SPIRITS ARE
SHOWCASED TO THE GENERAL PUBLIC AND AT WHICH THE GENERAL PUBLIC CAN
PURCHASE AND SAMPLE THE SPIRITS BEING SHOWCASED FOR CONSUMPTION ON
