SENATE BILL No. 374

May 10, 2017, Introduced by Senator SCHMIDT and referred to the Committee on Transportation.

A bill to amend 1949 PA 300, entitled "Michigan vehicle code,"

by amending section 224 (MCL 257.224), as amended by 2013 PA 179.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 224. (1) Except as otherwise provided in this act
 regarding tabs or stickers, upon registering a vehicle, the
 secretary of state shall issue to the owner 1 registration plate.

4 (2) A registration plate shall display the registration number
5 assigned to the vehicle for which the registration plate is issued;
6 the name of this state, which may be abbreviated; and when the
7 registration plate expires, which may be shown by a tab or sticker
8 furnished by the secretary of state.

9 (3) A registration plate issued for motor vehicles owned and
0 operated by this state; a state institution; a municipality; a
1 privately incorporated, nonprofit volunteer fire department; or a

nonpublic, nonprofit college or university of this state shall DOES 1 2 not expire at any particular time but shall be renewed when the registration plate is worn out or is illegible. This registration 3 4 plate shall be assigned upon proper application and payment of the applicable fee and may be used on any eligible vehicle titled to 5 the applicant if a written record is kept of the vehicles upon 6 which the registration plate is used. The written record shall 7 state the time the registration plate is used on a particular 8 9 vehicle. The record shall be open to inspection by a law 10 enforcement officer or a representative of the secretary of state.

11 (4) A registration plate issued for a vehicle owned by the civil air patrol as organized under 36 USC 201 to 208; a vehicle 12 owned by a nonprofit organization and used to transport equipment 13 14 for providing dialysis treatment to children at camp; an emergency support vehicle used exclusively for emergencies and owned and 15 operated by a federally recognized nonprofit charitable 16 17 organization; a vehicle owned and operated by a nonprofit veterans center; a motor vehicle having a truck chassis and a locomotive or 18 19 ship's body which is owned by a nonprofit veterans organization and 20 used exclusively in parades and civic events; a vehicle owned and 21 operated by a nonprofit recycling center or a federally recognized 22 nonprofit conservation organization until December 31, 2000; a 23 motor vehicle owned and operated by a senior citizen center; and a 24 registration plate issued for buses including station wagons, 25 carryalls, or similarly constructed vehicles owned and operated by 26 a nonprofit parents' transportation corporation used for school 27 purposes, parochial school, society, church Sunday school, or other

1 grammar school, or by a nonprofit youth organization or nonprofit 2 rehabilitation facility shall be issued upon proper application and payment of the applicable tax provided in section 801(1)(g) or (h) 3 4 to the applicant for the vehicle identified in the application. The 5 vehicle shall be used exclusively for activities of the school or 6 organization and shall be designated by proper signs showing the school or organization operating the vehicle. The registration 7 plate shall expire EXPIRES on December 31 in the fifth year 8 9 following the date of issuance. The registration plate may be 10 transferred to another vehicle upon proper application and payment 11 of a \$10.00 transfer fee.

12 (5) The department shall offer a standard design registration 13 plate that complies with the requirements of this act. The standard 14 design registration plate shall be of a common color scheme and design that is made of fully reflectorized material and shall be IS 15 clearly visible at night. NO LATER THAN JANUARY 1,2018, THE 16 DEPARTMENT SHALL USE A DIGITAL PRINTING METHOD TO CREATE ALL 17 STANDARD DESIGN REGISTRATION PLATES. AS USED IN THIS SUBSECTION, 18 "DIGITAL PRINTING METHOD" MEANS A METHOD OF CREATING A REGISTRATION 19 20 PLATE USING A RETROFLECTIVE SHEETING MATERIAL THAT IS PRINTED UTILIZING UV-CURABLE INK-JET TECHNOLOGY TO ACHIEVE THE HIGHEST 21 22 QUALITY AND SPEED OF PRINTING.

(6) The department may use the Pure Michigan brand or a
successor or similar brand that is used in conjunction with this
state's promotion, travel, and tourism campaigns or marketing
efforts as part of the standard design for registration plates.
(7) The registration plate and the required letters and

numerals on the registration plate shall be of sufficient size to
 be plainly readable from a distance of 100 feet during daylight.
 The secretary of state may issue a tab or tabs designating the
 month and year of expiration.

5 (8) The secretary of state shall issue for every passenger
6 motor vehicle rented without a driver the same type of registration
7 plate as the type of registration plate issued for private
8 passenger vehicles.

9 (9) A person shall not operate a vehicle on the public
10 highways or streets of this state displaying a registration plate
11 other than the registration plate issued for the vehicle by the
12 secretary of state, except as provided in this chapter for
13 nonresidents, or by assignment as provided in subsection (3).

14 (10) The registration plate displayed on a vehicle registered
15 on the basis of elected gross weight shall indicate the elected
16 gross weight for which the vehicle is registered.

(11) Beginning on January 1, 2015, THE SECRETARY OF STATE 17 SHALL NOT RENEW a registration plate issued by the department under 18 this section shall not be renewed 10 years after the date that 19 20 registration plate was issued. The owner of a vehicle whose 21 registration plate is no longer eligible for renewal under this 22 subsection shall obtain a replacement registration plate upon 23 payment of the fee required under section 804. For any alphanumeric 24 series that the department has retired from circulation, upon 25 request of the owner of a vehicle whose registration plate is no 26 longer eligible for renewal under this subsection, the department 27 may issue a new registration plate with the same registration

number as was displayed on the expired registration plate as
 provided under section 803b.

(12) The secretary of state, in conjunction with the 3 4 department of corrections, the Michigan state police, the Michigan sheriffs' association, 1 individual appointed by the speaker of the 5 house of representatives, and 1 individual appointed by the senate 6 majority leader, shall prepare a report analyzing the viability of 7 moving from the current registration plate production process to a 8 digital printing of registration plates. The secretary of state 9 shall submit the report to the standing committees of the senate 10 11 and house of representatives with primary responsibility for transportation issues no later than December 31, 2013. 12 Enacting section 1. This amendatory act takes effect 90 days 13 after the date it is enacted into law. 14
