Introduction of Bills

Rep. Hauck introduced

House Bill No. 5334, entitled

A bill to amend 1949 PA 300, entitled "Michigan vehicle code," (MCL 257.1 to 257.923) by adding section 811hh.

The bill was read a first time by its title and referred to the Committee on Transportation.

Reps. Damoose, Wozniak, Bezotte, Yaroch, Markkanen and Slagh introduced

House Bill No. 5335, entitled

A bill to amend 1954 PA 116, entitled "Michigan election law," by amending section 735 (MCL 168.735), as amended by 2004 PA 92, and by adding section 730b.

The bill was read a first time by its title and referred to the Committee on Elections and Ethics.

House Bill No. 5336, entitled

A bill to amend 1954 PA 116, entitled "Michigan election law," by amending section 492a (MCL 168.492a), as amended by 2018 PA 125; and to repeal acts and parts of acts.

The bill was read a first time by its title and referred to the Committee on Elections and Ethics.

House Bill No. 5337, entitled

A bill to amend 1893 PA 206, entitled "The general property tax act," by amending section 34d (MCL 211.34d), as amended by 2019 PA 117.

The bill was read a first time by its title and referred to the Committee on Local Government and Municipal Finance.

House Bill No. 5338, entitled

A bill to amend 1961 PA 236, entitled "Revised judicature act of 1961," by amending section 8154 (MCL 600.8154), as amended by 2012 PA 20.

The bill was read a first time by its title and referred to the Committee on Judiciary.

Reps. Bollin, Paquette, Calley, Steven Johnson, Kahle, O'Malley, Maddock, Huizenga, Eisen and Outman introduced

House Bill No. 5339, entitled

A bill to amend 1978 PA 368, entitled "Public health code," by amending section 2453 (MCL 333.2453) and by adding section 2453a.

The bill was read a first time by its title and referred to the Committee on Government Operations.

Rep. Whiteford introduced

House Bill No. 5340, entitled

A bill to amend 1961 PA 236, entitled "Revised judicature act of 1961," by amending section 1082 (MCL 600.1082), as amended by 2012 PA 334, and by adding chapter 10D.

The bill was read a first time by its title and referred to the Committee on Judiciary.

Reps. Steven Johnson, Slagh, Fink, LaFave, Markkanen, Meerman and Hornberger introduced

House Bill No. 5341, entitled

A bill to amend 1956 PA 218, entitled "The insurance code of 1956," by amending section 3107c (MCL 500.3107c), as added by 2019 PA 22.

The bill was read a first time by its title and referred to the Committee on Insurance.

Reps. Meerman and Slagh introduced

House Bill No. 5342, entitled

A bill to amend 1994 PA 451, entitled "Natural resources and environmental protection act," (MCL 324.101 to 324.90106) by adding section 504b.

The bill was read a first time by its title and referred to the Committee on Natural Resources and Outdoor Recreation.
