# (Enacted as Public Act 105 of 2023)

#### **SUMMARY:**

Senate Bill 288 would amend the Michigan Energy Assistance Act to repeal a section that now provides that the act will no longer apply after September 30, 2023. (These sorts of provisions are sometimes known as "sunset provisions" or simply "sunsets.")

The Michigan Energy Assistance Act requires the Department of Health and Human Services to establish and administer the Michigan Energy Assistance Program (MEAP). The program provides assistance to eligible low-income households in meeting their home energy costs through payment or partial payment of their bills for electricity, natural gas, propane, heating oil, or other heating fuels. The assistance also includes services that will enable participants to become more self-sufficient in minimizing, budgeting, and paying their energy costs. The department, in consultation, with the Michigan Public Service Commission, can contract with public or private entities, including local units of government, to provide energy assistance.

The Michigan Energy Assistance Act was enacted in 2012 and went into effect March 28, 2013. The act originally included a section providing that it would no longer apply after September 30, 2016. This expiration date has been extended twice—to September 30, 2019, and to September 30, 2023. The bill would repeal this section, eliminating the act's sunset entirely.
