Overview

House Bill 4016 (S-1) contains supplemental appropriation adjustments to multiple state department budgets for FY 2021-22 and FY 2022-23. In sum, FY 2021-22 adjustments total \$0.0 million Gross (\$0.0 million GF/GP) and FY 2022-23 adjustments total \$1.3 billion Gross (\$828.6 million GF/GP).

Appropriation and boilerplate priorities initiated by the legislature and the State Budget Office are identified below.

GENERAL SECTIONS

Sec. 201. State Spending and State Appropriations Paid to Local Units of Government

States amount of state spending from state sources in the bill and amount of state spending to be paid to local units of government.

Sec. 202. Appropriations Subject to Management and Budget Act

Subjects appropriations to the Management and Budget Act, 1984 PA 431.

Sec. 203. Allocation and Expenditure of Appropriations

Requires allocation and expenditure of appropriations in a manner consistent with federal rules and regulations.

Sec. 204. Appropriations Subject to Federal Audit and Reporting Requirements

Subjects appropriations to applicable federal audit and reporting requirements; requires prompt action if instances of noncompliance are identified; requires the state budget director to notify appropriations committees and fiscal agencies of instances of noncompliance.

Sec. 205. Report on Status of Federal COVID Relief Appropriations

Requires the state budget director to report on the status of all funds appropriated related to the coronavirus relief effort on a monthly basis until all funds are exhausted.

FY 2022-23 Supplemental Boilerplate Items

ENVIRONMENT, GREAT LAKES, AND ENERGY

Sec. 401. Environmental Sustainability and Stewardship

Designates unexpended funds as a work project appropriation; funds would be provided to homeowners and landlords for U.S. Department of Energy-approved energy efficiency upgrades.

Sec. 402. Mineral Wells

Requires funding to be used to support the increase in statewide oversight of disposal wells, perform necessary compliance and enforcement activities, and support any remedial actions deemed necessary by the department; requires the department to prioritize activities that pose an immediate environment hazard, including oversight of and hazardous substances imported for disposal into wells located in Wayne County; designates unexpended funds as a work project appropriation.

HEALTH AND HUMAN SERVICES

Sec. 501. Water Affordability

Requires funding to be allocated for grants to qualified providers for income-based programming for restoring residential water services, paying water bill arrears, supporting payment plans, and protecting water shutoffs; defines qualified providers; designates unexpended funds as a work project appropriation.

Sec. 502. ARP – Nursing Home Workforce

Requires funding to be used to provide grants to support long-term care workforce recruitment, retention, training, or career development; designates unexpended funds as a work project appropriation.

Sec. 503. Medicaid Long-Term Care Services

Requires DHHS to adjust the interim variable cost component and plant cost component of Medicaid reimbursements to nursing homes to 102% of the interim rate provided in the enacted FY 2022-23 DHHS budget; outlines the calculation of the quality assurance supplement; requires DHHS to audit final variable cost component and plant costs.

Sec. 504. ARP – Community Violence Initiative

Requires DHHS to provide grants to community-based organizations that provide community violence intervention services; requires at least 50% of grant funding to be awarded to disproportionately affected communities; designates unexpended funds as a work project appropriation.

Sec. 505. ARP – Health Care Recruitment, Retention, and Training

Requires funding to be used for health care recruitment, retention, and training programming for acute care and behavioral health care providers; requests the Michigan Health and Hospital Association to administer the program; prohibits funds from being used to support recruitment or retention programming announced before December 1, 2021.

LABOR AND ECONOMIC OPPORTUNITY

Sec. 701. Strategic Outreach and Attraction Reserve Fund (SOAR)

Requires SOAR funding to be deposited into the SOAR fund established in section 4 of the Michigan Trust Fund Act, 2000 PA 489.

Sec. 702. Contingency Authorization for Strategic Outreach and Attraction Reserve Fund

Appropriates \$170.3 million state restricted contingency authorization; funding would be available for expenditure after transfer to another line item under section 393(2) of the Management and Budget Act, 1984 PA 431.

Sec. 703. Community Development Block Grant

Designates unexpended funds as a work project appropriation; funds would be used to support disaster recovery efforts.

Sec. 704. State Digital Equity Planning Grant

Designates unexpended funds as a work project appropriation; funds would be used to support digital equity planning efforts, identify barriers to digital equity, and develop strategies for overcoming the barriers.

Sec. 705. ARP – Community and Neighborhood Initiatives

Requires funding to be used to support a competitive grant program for certain projects at eligible community centers owned by a municipality, local government agency, or nonprofit organization and in good financial standing; requires applicants to submit a project budget; authorizes grants to be awarded only to community centers that are free and open to the public and that offer at least one eligible community service; prohibits grants from exceeding \$2.5 million for any community project; requires an eligible community center to either serve a community that was disproportionately affected by the COVID-19 pandemic or be owned by a nonprofit organization that was affected; requires quarterly reports from grant recipients; authorizes the department to use up to 2.5% of funds for administration of grants; designates unexpended funds as a work project appropriation.

Sec. 706. Mega-Strategic Site Development

Requires the Michigan Strategic Fund to grant funds for land acquisition and predevelopment site work related to the development of a mega-strategic site located in Marshall; allows the grantee to subcontract with appropriate professional services providers; states that the legislature finds and declares funding is to be used for a public purpose and to serve the health, safety, and general welfare of residents of the state; designates unexpended funds as a work project appropriation.

FY 2022-23 Supplemental Boilerplate Items

Sec. 707. Arts and Cultural Program

Requires funding for the Arts and Cultural Program be awarded to non-profit organizations impacted by the COVID-19 pandemic; requires expenditures to comply with federal regulations established by the federal American Rescue Plan Act.

Sec. 708. Career and Technical Education Complex

Requires LEO to award funding to North Central Michigan College for the Career and Technical Education Complex.

Sec. 709. Housing Gap Financing and Affordable Housing

Requires funding to be used by MSHDA to create a program to assist in implementation of Michigan's statewide housing plan by reducing housing cost burdens on residents and increasing the supply of affordable housing; requires funding to be used to help defray costs of eligible projects sponsored by for-profit and nonprofit developers that help increase the affordable housing supply; requires grants or loans to be allocated for projects that qualify for tax credits under section 42 of the Internal Revenue code of 1986 – 40.0% as grant or forgivable loan for construction of new housing units through pass-through bond program, 20.0% as grant or forgivable loan for construction of new housing units through pass-through bond program, 20.0% as grant or forgivable loan for projects that qualify for tax credits under Internal Revenue Code of 1986, 25.0% as grant, loan, or forgivable loan for projects that have already received loans or meet other requirements, and 15.0% as a grant or forgivable loan for properties that previously received tax credits under the Internal Revenue Code of 1986 or are the subject of an existing use restriction for projects tax credits, or receive an allocation cap through pass-through bond program; prohibits more than 15% from being allocated for projects in rural communities designated by the U.S. Department of Agriculture and Rural Development; designates unexpended funds as a work project appropriation.

Sec. 710. Student Aviation Center

Requires LEO to award funding for renovation of hangers used for the aviation program at Northwestern Michigan College and for acquisition of additional aircraft that would be used for instruction of student pilots.

NATURAL RESOURCES

Sec. 901. ARP – Lake Erie and Saginaw Bay Watershed Wetland Restoration, Enhancement, and Acquisition

Requires funding to be used for acquisition and rehabilitation of wetlands in the Lake Erie and Saginaw Bay watersheds to reduce nitrogen, phosphorus, or sediment in the water; authorizes funding to be granted to qualifying nongovernmental conservation organizations; requires expenditures to comply with provisions of the federal American Rescue Plan Act.

TRANSPORTATION

Sec. 1001. Economic Development Project

Requires MDOT to enter into a memorandum of understanding with the Michigan Strategic Fund, or the Marshall Area Economic Development Alliance, or both; states that the legislature finds and declares funding is to be used for a public purpose and to serve the health, safety, and general welfare of residents of the state; requires funds to be used to support Michigan Strategic Site Readiness program activities; prohibits use of funds to provide grants or other funds to a railroad company.

Sec. 1201. State Spending and State Appropriations Paid to Local Units of Government

States amount of state spending from state sources in the bill and amount of state spending to be paid to local units of government.

Sec. 1202. Appropriations Subject to Management and Budget Act

Subjects appropriations to the Management and Budget Act, 1984 PA 431.

STATE POLICE

Sec. 1401. Public Safety Academy Assistance Programs

Requires funding to be distributed by MCOLES or the Department of Treasury to provide grants of up to \$24,000 per applicant through a competitive program to provide recruit scholarships and salaries to local public safety department police cadets, on a first-come, first-serve basis, for applicants who satisfy the requirements and enroll in a police academy program; stipulates requirements that applicants must meet to receive a scholarship, including having been successfully screened by a local public safety department for MCOLES' selection and employment standards, having received an offer of employment, and enrolling in a basic law enforcement training academy; establishes a 25-scholarship cap for local public safety departments; authorizes MCOLES to use up to \$140,000 of the appropriation for administration; stipulates that any awards prior to this bill may be amended if both MCOLES and the grantee agree; designates unexpended funds as a work project appropriation.

REPEALERS

Sec. 1601. Repeal Public Safety Academy Assistance Programs

Repeals section 708 of Article 15 of 2022 PA 166 and replaces it with section 1401 of this bill.

Sec. 1602. Repeals Housing Gap Financing and Water Shutoff Prevention Fund

Repeals section 307, Housing Gap Financing and Affordable Housing language, and section 601, Water Shutoff Prevention Fund language, of 2023 PA 1.
