A bill to amend 1979 PA 94, entitled "The state school aid act of 1979,"

by amending section 11 (MCL 388.1611), as amended by 2023 PA 3, and by adding section 220.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 11. (1) For the fiscal year ending September 30, 2022,
- 2 there is appropriated for the public schools of this state and
