- 2 Sec. 2. As used in this act:
- 3 (a) "Community district education trust fund" means the4 community district education trust fund created in section 12.
- 5 (b) "Flint settlement trust fund" means the Flint settlement6 trust fund created in section 11.
- 7 (c) "Local government reimbursement fund" means the local8 government reimbursement fund created in section 3a.
 - (d) "Medicaid benefits trust fund" means the Michigan Medicaid benefits trust fund established in section 5.

- 26 (i) For any distribution made under this subdivision between
- 27 October 1, 2026 and September 30, 2028, if a city's, village's, or

- 2 not decrease by at least 5% from the base crime level, the state
- 3 treasurer must reduce the city's or village's distribution amount,

- 5 5% and proportionally reallocate the reduced amount to the cities,
- 6 villages, and counties whose distributions are not reduced under
- 7 this subparagraph.
- 8 (ii) For any distribution made under this subdivision after
- 9 September 30, 2028, if a city's, village's, or township's rate of
- 10 violent crime, as determined by the most recent annual crime report
- 11 published by the department of state police as of the first day of
- 12 the state fiscal year of the distribution, did not decrease by at
- 13 least 5% from the base crime level, the state treasurer shall
- 14 reduce the city's or village's distribution amount, or the amount
- 15 distributed to the county on behalf of a township, by 10% and
- 16 proportionally reallocate the reduced amount to the cities,
- 17 villages, and counties whose distributions are not reduced under
- 18 this subparagraph.
- 19 (c) A city, village, or township, or a county on behalf of a
- 20 township, is not entitled to receive more than 25% of the total
- 21 distribution under this subsection.
- 22 (4) Both of the following apply to a city, village, township,
- 23 or county that receives a grant under subsection (1):
- 24 (a) The city, village, township, or county may not use the
- 25 grant to obtain a vehicle weighing more than 15,000 pounds that is
- 26 designed or used for a tactical police purpose.
- 27 (b) The city, village, township, or county may subgrant all or
- 28 part of the grant if the subgrant is used for the purpose described
- 29 in subsection (1).



- 1 (5) All of the following apply to a distribution under 2 subsection (3):
- (a) Except as otherwise provided in subdivisions (b) and (c), a city, village, township, or county that receives a distribution, and a sheriff's department of a county that is contracted by the city, village, or township to provide police services, shall use the distribution for the purposes of public safety and violence prevention.
- 9 (b) A city, village, township, or county that receives a 10 distribution may not use the distribution to replace or supplant 11 its existing reoccurring resources for public safety and violence prevention, unless there is a decline in the estimated total 12 general fund revenue of the city, village, township, or county from 13 14 the previous fiscal year and there is a reduction in the existing 15 reoccurring resources of the city, village, township, or county that is proportional to the estimated decline in the general fund 16 17 revenue.
- 18 (c) A city, village, township, or county may not use the 19 distribution to obtain a vehicle weighing more than 15,000 pounds 20 that is designed or used for a tactical police purpose.
- 21 (d) A city, village, township, or county may subgrant all or 22 part of the distribution if the subgrant is used for the purpose 23 described in subdivision (a).
 - (6) Money in the public safety and violence prevention fund must not be transferred, expended, withdrawn, or otherwise distributed except as otherwise provided in this section.
- 27 (7) For each state fiscal year that begins after September 30, 28 2024, the governor and the state budget director shall include in 29 the annual budget for that fiscal year submitted to the legislature
