Introduced by Senators Gast, Holmes and Geake

ENROLLED SENATE BILL No. 125

AN ACT to make appropriations for the department of natural resources for the fiscal year ending September 30, 1988; to provide for the expenditure of those appropriations; to create funds and accounts and a council; to require reports; to prescribe certain powers and duties of certain state departments and officers, institutions, and agencies; to authorize certain transfers by certain state agencies; to require the conveyance of certain property under the jurisdiction of the department of natural resources; and to provide for the disposition of fees and other income received by the various state agencies.

The People of the State of Michigan enact:

Sec. 1. There is appropriated for the department of natural resources for the fiscal year ending September 30, 1988, from the following funds:

(2) When it appears to the principal executive officer of each department that state spending to local units of government will be less than the amount that was projected to be expended for any quarter, the principal executive officer shall immediately give notice of the approximate shortfall to the department of management and budget, the senate and house appropriations committees, and the senate and house fiscal agencies.

Sec. 3. The appropriations made and the expenditures authorized under this act and the departments, agencies, commissions, boards, offices, and programs for which an appropriation is made under this act are subject to the management and budget act, Act No. 431 of the Public Acts of 1984, being sections 18.1101 to 18.1594 of the Michigan Compiled Laws.

Sec. 4. As used in this act:

- (a) "CESARS" means chemical evaluation search and retrieval system.
- (b) "DAG-FS" means the United States department of agriculture-forest service.
- (c) "DOC-NOAA" means the United States department of commerce-national oceanic and atmospheric administration.
- (d) "DOD-ARMY" means the United States department of defense-army.
- (e) "DOD-NAVY" means the United States department of defense-navy.
- (f) "DOE" means the United States department of energy.
- (g) "DOI" means the United States department of interior.
- (h) "DOI-FWS" means the DOI-fish and wildlife service.
- (i) "DOI-NPS" means the DOI-national park service.
- (j) "DOI-OSMRE" means the DOI-office of surface mining reclamation and enforcement.
- (k) "DOI-OWRT" means the DOI-office of water research and technology.
- (l) "DOT" means the United States department of transportation.
- (m) "EPA" means the United States environmental protection agency.
- (n) "EPA-LUST trust" means the EPA-leaking underground storage tank trust fund.
- (o) "EPA-OPM" means the EPA-office of program management.
- (p) "EPA-ORD" means the EPA-office of research and development.
- (q) "EPA-OWWM" means the EPA-office of water and waste management.
- (r) "FTE" means full-time equated.

Sec. 5. The appropriations in section 1 may be used for per diem payments to the members of commissions for a full day's committee work at which a quorum is present, for attending a hearing as authorized by the respective commissions, or for performing official business as authorized by each respective commission. The per diem payments shall be at a rate as follows:

- (a) Commission of natural resources..... \$75.00 per day
- (b) State resource recovery commission \$50.00 per day
- (c) Hazardous waste management planning committee..... \$50.00 per day
- (d) Toxic substance control commission \$100.00 per day

Sec. 6. The department of natural resources may charge the appropriations contained in section 1 including all special maintenance and capital projects appropriated for the fiscal year ending September 30, 1988, for the engineering services provided, a standard percentage fee to be determined by the state budget director, and may use the revenue derived to support the engineering services charges provided for in section 1.

Sec. 7. The department of natural resources may charge land acquisition projects appropriated for the fiscal year ending September 30, 1988, and for prior fiscal years, a standard percentage fee to be determined by the

state budget director, and may use the revenue derived to support the land acquisition service charges provided for in section 1.

Sec. 8. (1) There is created and established under the jurisdiction and control of the department of natural resources a revolving account to be known as the MacMullan conference center account. The account shall receive all fees or other revenues generated from operation of the MacMullan conference center. Appropriations shall be made from the account for support of programs operations and all maintenance and operations of the facility, and shall not exceed the estimated revenues for the fiscal year in which they are made, together with any unexpended balances from prior years. An annual report of operations and expenditures shall be submitted to the appropriations committees of the senate and house of representatives and the house and senate fiscal agencies at the end of the fiscal year.

(2) The MacMullan conference center shall be uniformly available to any group or organization dedicated to utilization, protection, and economic development of the state's natural resources. An annual report of the amount of money expended and the nature of training sessions that were held shall be submitted to the appropriations committees of the senate and house of representatives and the house and senate fiscal agencies at the end of the fiscal year.

Sec. 9. When funds are expended from the appropriation in section 1 for water cleaning emergency funds for use by the department of natural resources, the department shall do all within its powers to ascertain who was at fault in causing a spill or leakage which to remedy the situation necessitated the use of the emergency fund. When possible, the department shall charge and collect from the party responsible for the spill or leakage, the costs incurred by the department in remedying the situation. Funds collected, after the costs of collection, shall be returned to the water cleaning emergency fund. Notwithstanding any other section of this act, these funds are hereby appropriated and allocated for expenditure when received. The department shall report to the appropriations committees of the house of representatives and senate and the house and senate fiscal agencies, the status, use, and results of the water cleaning emergency fund in January, April, July, and October of each year.

Sec. 10. The department of natural resources may contract with the department of public health or the department of agriculture, or both, for the purpose of laboratory tests, monitoring, or analyses in connection with the industrial surveillance program. The department performing the service shall bill the department receiving the service for the necessary costs of the service. A department shall pay each bill received for services rendered pursuant to this section.

Sec. 11. The department of state may carry over unexpended snowmobile and off-road vehicle fee collections as authorized by Act No. 74 of the Public Acts of 1968, being sections 257.1501 to 257.1518 of the Michigan Compiled Laws, and Act No. 319 of the Public Acts of 1975, being sections 257.1601 to 257.1626 of the Michigan Compiled Laws, to fund following year programs in the department of state and the department of natural resources as appropriated by the legislature.

Sec. 12. The department of natural resources shall report on February 1, 1988, to the senate and house of representatives appropriations committees and to the senate and house fiscal agencies. The report shall include:

(a) The amount of contributions, gifts, bequests, grants, and donations received by the department for the fiscal year ending September 30, 1987.

(b) A listing of the expenditures made from the amounts received as reported in subdivision (a).

Sec. 13. The commission of natural resources shall provide that each concession in a state park shall be awarded every 7 years based upon renegotiation or competitive bidding. The award of each concession in a state park shall be approved by the commission of natural resources.

Sec. 14. Amounts appropriated in this act to the department of natural resources shall not be used to purchase any airplane or helicopter, or any boat over 21 feet in length.

Sec. 15. From fees collected pursuant to section 22 of Act No. 61 of the Public Acts of 1939, being section 319.22 of the Michigan Compiled Laws, there is appropriated \$125,000.00 to be known as the brine loss investigation fund which shall be utilized by the supervisor of wells for response and investigation of existing or future alleged instances of groundwater contamination resulting from drilling or operation of oil or gas wells. If necessary, and after consultation with the oil and gas advisory board, the supervisor of wells may negotiate and authorize direct contractual services for surface of hydrogeologic investigations. The fund shall not be used for research or for soil or groundwater sampling where verified complaints do not exist.

Sec. 16. The department of natural resources when purchasing any equipment or supplies with funds appropriated in section 1, shall give preference to those items manufactured, assembled, or sold in this state.

Sec. 17. The land and lease sale service charges fund is created. An amount equal to the cost of personal services, printing, postage, advertising, contractual services, and facility rental associated with the sale of oil, gas, and mineral leases and tax reverted lands shall be deducted from the sales and leases and credited to the land and lease sale service charges fund.

Sec. 18. Of the funds appropriated in section 1 for superfund program development, the department shall contract, to the extent practicable, with the private sector for the operation of that program.

Sec. 19. The department of natural resources shall lease for not more than \$1.00 a year a portion of the department owned building in Powell township to Powell township.

Sec. 20. The department of natural resources may carry forward the unexpended revenue collected for wildfire prevention and the Roscommon equipment center. Expenditure shall not exceed revenue collected for the fiscal year together with any unexpended balances of the prior fiscal year.

Sec. 21. (1) Under the appropriation in section 1 for the Act 307 cleanup program, the department of natural resources shall continue to make authorizations for site evaluation, interim response activity, final response activity, and contingencies for all environmental contamination sites and for the administration of the program created by the environmental response act, Act No. 307 of the Public Acts of 1982, being sections 299.601 to 299.611 of the Michigan Compiled Laws.

(2) The department of natural resources shall report the following information relative to allocations made from the line "Act 307 cleanup" in section 1 to the senate and house appropriations committees and the senate and house fiscal agencies:

- (a) The name and location of the site for which an allocation is made.
- (b) The nature of the problem encountered at the site.
- (c) The estimated time necessary to prepare plans or complete any necessary study if the allocation is for plans or a study.
- (d) A brief description of how the problem will be resolved if the allocation is made for a response activity.
- (e) The estimated time to complete the response activity if the allocation is for a response activity.
- (f) The amount of the allocation.

(3) The report shall be made available as follows:

(4) The unexpended portion of the \$11,355,500.00 appropriation in section 1 to the department of natural resources, Act 307 cleanups remaining at the end of the fiscal year ending September 30, 1988, shall not lapse to the fund from which appropriated but shall continue to be available for the purposes for which it was appropriated. The funds carried forward into the next fiscal year pursuant to this section shall be used at the discretion of the director of the department of natural resources for remedial actions only for those sites evaluated under the site assessment system created in the environmental response act, Act No. 307 of the Public Acts of 1982, being sections 299.601 to 299.611 of the Michigan Compiled Laws.

Sec. 22. (1) The department of natural resources shall report the following information relative to site specific cooperative agreements made from the line "superfund cleanup" to the senate and house appropriations committees and the senate and house fiscal agencies:

- (a) The name and location of the site for which the site specific cooperative agreement is made.
- (b) The nature of the problem encountered at the site.
- (c) The estimated time to prepare plans or complete any necessary study if the allocation is for plans or a study.
- (d) A brief description of how the problem will be resolved if the allocation is made for a remedy.
- (e) The estimated time to complete the remedy of the problem if the allocation is for a remedy.
- (f) The amount of the anticipated financing for the site.

(2) The report shall be made available as follows:

(2) Of the state general fund/general purpose resources appropriated in section 1 to resource preservation law enforcement, \$2,015,300.00 is to provide reimbursement to the game and fish protection fund for senior citizen reimbursement.

(3) Of the state general fund/general purpose resources appropriated in section 1 to purchase lands, \$484,800.00 is to provide reimbursement to the game and fish protection fund for the first year of a 5-year phase-in of general fund support of 50% of the total tax payments due to local units for lands acquired with hunting and fishing license fees from the game and fish protection fund.

Sec. 24. The funds appropriated in section 1 shall not be used by the staff of any district or regional office of the department of natural resources to require any farmer or vegetable or fruit processor to acquire either a surface or groundwater permit for the discharge of water used in the production of food for human consumption if the water used is either spray-aerated or suitably disposed of on the lands owned by the farmer or processor and if the boundary of property used for these activities is located at least 1,500 feet from any named stream or lake in the state.

Sec. 25. The department shall report to the house and senate appropriations subcommittees on natural resources those local units of government which received hazardous waste grants from the funds appropriated in section 1.

Sec. 26. Before any of the \$250,000.00 appropriated in section 1 for groundwater compliance grants is committed, the department shall submit to the senate and house appropriations subcommittees on natural resources a list of the projects and the local governmental units proposed to be funded by the appropriation.

Sec. 27. (1) The director of the department of management and budget is authorized to make administrative transfers in such amounts as may be necessary from amounts appropriated in section 1 to cover current deficits created by prorated monthly sick leave payments resulting from employees retiring under section 19a of the state employee's retirement act, Act No. 240 of the Public Acts of 1943, being section 38.19a of the Michigan Compiled Laws.

(2) The department of management and budget shall report to the house and senate appropriations committees the listing of all administrative transfers made under the authority of subsection (1).

Sec. 28. In administering the federal land and water conservation grant program, the department shall not adopt a policy that discriminates against providing funding to small communities in this state.

Sec. 29. (1) The department of natural resources shall report the following to the senate and house appropriations committees and the senate and house fiscal agencies:

(a) A summary of cases, both civil and criminal, in which the department requested prosecution or was a plaintiff in which a judgment was entered or a settlement was entered into.

(b) The name of the defendant for each case.

(c) The disposition of each case.

(d) The county in which the case was tried or settled.

(e) The amount and disposition of any judgment or settlement.

(f) The nature of the lawsuit.

(2) The report shall be issued before the twenty-eighth of each month for the reporting period that shall consist of the previous month.

Sec. 30. The department of natural resources shall report to the house and senate appropriations subcommittees on natural resources within 30 days before April 30, 1988 and within 30 days before October 30, 1988 on the status of the department's efforts to reduce the existing backlog of groundwater discharge permits.

Sec. 31. The department of natural resources shall not offer for public sale any mineral rights of which it is the owner until the department has the permission of the owner of the surface rights to that land.

Sec. 32. (1) The state administrative board shall convey, without consideration, property now under the jurisdiction of the department of natural resources and located in Michigamme township, Marquette county, to Michigamme township. The property is the westerly 800 feet lying north of the existing county road, Government Lot 1, Section 36, T48N, R38W.

(2) The description of the parcel contained in subsection (1) is approximate and is subject to adjustment as considered necessary by the department of management and budget.

(3) The conveyance authorized by this section shall be by quitclaim deed approved by the attorney general.

Sec. 33. The department of natural resources shall submit to the house and senate fiscal agencies a quarterly report on the status of all FTE positions for which funds are appropriated in section 1 of this act. The reports shall be on a form approved by the house and senate fiscal agencies. The reports shall be submitted on October 1, 1987, January 2, 1988, April 1, 1988, July 1, 1988, and September 30, 1988.

Sec. 34. In carrying out the provisions of this act, should the director of the department of natural resources be required to lay off any department employees, the director shall be exempted from using a strict application of continuous service credits in accordance with guidelines developed by the state personnel director and approved by the civil service commission in order to preserve affirmative action gains made in a program approved by the Michigan equal employment and business opportunity council. This is in accordance with civil service commission rule 2-19.3d.

Sec. 35. (1) The department of natural resources and the department of civil service are directed to work together to establish a common classification for forestry paraprofessionals.

(2) Any vacancies in classified positions filled in either the timber harvest program or the forest fire program shall be filled by graduate foresters who shall act as both fire fighters and timber harvesters.

Sec. 36. Of the funds appropriated in section 1 for inland fisheries, a sufficient portion is appropriated to provide for the management of Lake Angeline in Marquette county as a trout fishery. This shall include the netting and removal of undesirable fish species and the planting of trout species.

Sec. 37. Of the total funds appropriated in section 1 for state park operations, the department shall expend \$40,000.00 to contract with Saginaw valley state college and Delta community college to operate the Jenison trial side museum interpretive center at Bay City state park.

Sec. 38. The department of natural resources, together with the department of management and budget, shall present to the house and senate appropriations subcommittees on natural resources a plan to eliminate the projected deficit in the state fair revolving fund by the end of the 1988 fiscal year. The plan shall be submitted not later than October 1, 1987.

Sec. 39. Before December 31, 1987 the director of the department of natural resources shall report the department's employment reduction plan of \$550,000.00 state general fund/general purpose and 10 FTE's to the senate and house appropriations committees and the senate and house fiscal agencies. The employment reduction plan shall indicate how the FTE's will be reduced, which line item funded the positions, and when the reduction is to be effective.

Sec. 40. Of the \$11,788,700.00 appropriated in section 1 as state match for the superfund cleanup program, an amount not to exceed \$250,000.00 may be expended as state match for the hazardous substance research center appropriated in section 1.

Sec. 41. (1) The department of natural resources shall make recommendations to the house and senate appropriations subcommittees on natural resources on improving the productivity of the department's permit issuance activities. The report shall address at a minimum all of the following:

(a) The abolition or consolidation of commissions.

(b) The abolition or consolidation of permit requirements.

(c) The potential for private sector involvement through insurance mechanisms.

(d) A comparison of the number of hours expended in the process of reviewing and issuing a permit in this state in comparison with the length of time expended in reviewing and issuing a permit in other Great Lakes states.

(2) The report shall be presented not later than March 1, 1988.

Sec. 42. The section chief of the Great Lakes shoreland section of the land and water division shall prepare a bimonthly written report to the chairpersons of the house and senate appropriations subcommittee on natural resources. The report shall contain at a minimum:

(a) A description of every permit application received by the Great Lakes shorelands section the previous week.

(b) A detailed narrative of every meeting conducted by or attended by the Great Lakes shoreland section chief the previous week.

(c) The status of every permit application under the purview of the Great Lakes shoreland section. The status shall include, at a minimum, the date when each permit application was received, when the application is expected to be resolved, and a copy of each permit approved or denied. With each permit approved in a modified form or denied, an explanation shall be provided for the modification or denial.

Sec. 43. Included in the appropriation in section 1 for the state parks program is \$200,000.00 for the department to conduct a feasibility study on the establishment of a state park on Lake Superior in Marquette county and for site preparation.

Sec. 44. If a certified health department does not exist in a city, county, or district or does not fulfill its responsibilities under the septic waste servicers act, Act No. 181 of the Public Acts of 1986, being sections 325.311 to 325.332 of the Michigan Compiled Laws, then the department of natural resources may spend funds appropriated in section 1 under the septic waste compliance program in accordance with section 17(3) of the septic waste servicers act, Act No. 181 of the Public Acts of 1986.

(2) The department of natural resources may carry forward unexpended septic waste license fees collected for the septic waste compliance program. Expenditures shall not exceed revenue collected for the fiscal year together with any unexpended balances of the prior fiscal year.

Sec. 45. As a condition of expending the funds appropriated in section 1 for inland fisheries, the department shall request bids from local contractors for the cost of building a fish ladder on the Big Presque Isle river in Gogebic county. The department shall report to the senate and house appropriations subcommittees on natural resources on the responses of local contractors by January 1, 1988.

Sec. 46. With the grant appropriated in section 1 to the Michigan agricultural experiment station, the Michigan agricultural experiment station shall do all of the following:

(a) Conduct economic and environmental impact studies on tourism's impact on specific communities.

(b) Develop market assessment and forecasting to capitalize on Michigan's outdoor activity, to help the state's small businesses, and to revitalize rural Michigan.

(c) Develop products and processes from raw agricultural products to supply more of the state's food, feed, and fiber needs with the goal of increasing farm profitability and increasing agriculture's contribution to the economy of this state.

(d) Improve methods for detecting food chain contamination.

Sec. 47. With the grant appropriated in section 1 to the Michigan cooperative extension service, the Michigan cooperative extension service shall do all of the following:

(a) Help farms, businesses, and associations improve management and design of recreation and tourism facilities, and the training of their employees.

(b) Offer educational services to small businesses on record keeping, marketing, and investment strategies to help revitalize rural areas and to place increased emphasis on profitability.

(c) Promote wise management and multiple use of forest lands, capitalizing on recreation potential.

(d) Extend the commercial applications of research on wood processing, wood burning, and conversion of wood products to chemicals.

(e) Address soil erosion, nonpoint source pollution, chemical contamination, and water policy and rights challenges to reduce associated expenses and protect surface and groundwater resources.

Sec. 48. Of the \$5,879,100.00 appropriated in section 1 for public access sites, an amount not to exceed \$12,000.00 shall be expended on the hard surfacing of the access road to the waterways public access site on Craig lake in Branch county. The \$12,000.00 shall not be expended unless local and private funds are available in an equal amount to complete the project.

Sec. 49. The amount appropriated for Port Austin—Bird creek drain—dredging shall not be allocated unless Port Austin expends at least \$1,200.00 for the project.

Sec. 50. Of the total funds appropriated in section 1 for state park operations, the department shall expend \$80,000.00 to contract for operational assistance at the Muskegon state park.

Sec. 51. The appropriation in section 1 for a grant to the south Macomb disposal authority shall be expended for the cleanup of, or the actual closure of, landfills 9 and 9a operated by the south Macomb disposal authority.

Sec. 52. A marine safety advisory council is created. The council shall be composed of a representative of the Michigan sheriff's association, the Michigan association of counties, the department of natural resources, the department of management and budget, the senate fiscal agency and the house fiscal agency. Representatives of the senate and house fiscal agencies shall be members ex officio. The representatives shall be appointed by the association, department, or agency that they represent. The council shall report to the senate and house appropriations subcommittees on natural resources by March 1, 1988 with recommendations on guidelines for contracts, audits, program design, and program evaluation, for the marine safety program.

Sec. 53. Of the funds appropriated in section 1 for the enforcement of the Goemaere-Anderson wetland protection act, Act No. 203 of the Public Acts of 1979, being sections 281.701 to 281.722 of the Michigan Compiled Laws, the department of natural resources shall first make expenditures to assure the complete compliance with the department's responsibilities under sections 19 and 20 of Act No. 203 of the Public Acts of 1979. The department shall report to the senate and house appropriations subcommittees on natural resources by March 1, 1988 on its compliance with the requirements of this section.

Sec. 54. The commercial fishermen shall be paid the balance of \$7,162,495.00 to complete the buy out of the commercial fishermen. Of the \$7,162,495.00, \$2,600,000.00 shall be paid in fiscal year 1986-87, and the balance of \$4,562,495.00 shall be paid at 8% interest within the next 3 fiscal years.

This act is ordered to take immediate effect.
