- 1 CONSTITUENT SCHOOL DISTRICT SHALL RECEIVE HIS OR HER FULL WAGES
- 2 FROM THE SCHOOL DISTRICT OR INTERMEDIATE SCHOOL DISTRICT UNTIL
- 3 WEEKLY COMPENSATION BENEFITS UNDER THE WORKER'S DISABILITY COM-
- 4 PENSATION ACT OF 1969, ACT NO. 317 OF THE PUBLIC ACTS OF 1969,
