

HOUSE BILL No. 4664

May 21, 1987, Introduced by Reps. Allen, Pridnia, Alley, Bartnik, Gagliardi, Weeks, DeBeaussaert, Hertel, Muxlow, Knight, Docherty and Mathieu and referred to the Committee on Tourism and Recreation.

A bill to amend the title and section 1 of Act No. 145 of the Public Acts of 1897, entitled as amended

"An act for the protection of the keepers of hotels, inns, boarding houses, lodging houses, and furnished apartments,"

being section 427.201 of the Michigan Compiled Laws.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Section 1. The title and section 1 of Act No. 145 of the
2 Public Acts of 1897, being section 427.201 of the Michigan
3 Compiled Laws, are amended to read as follows:

4 TITLE

5 An act for the protection of the keepers of hotels, inns,
6 ~~boarding houses~~ BOARDINGHOUSES, lodging houses, BED AND
7 BREAKFASTS, and furnished apartments.

8 Sec. 1. (1) Whenever the keeper of any hotel, inn,
9 ~~boarding house~~ BOARDINGHOUSE, lodging house, BED AND BREAKFAST,

1 or furnished apartment ~~shall receive~~ RECEIVES into his OR HER
2 hotel, inn, ~~boarding house~~ BOARDINGHOUSE, lodging house, BED
3 AND BREAKFAST, or furnished apartment any person, guest, boarder,
4 lodger, or tenant, ~~he~~ THE KEEPER shall have a lien upon and
5 right to detain the goods, baggage, and effects of such guest,
6 boarder, lodger, or tenant to secure and compel the payment of
7 ~~his~~ customary charges for the food and lodging furnished ~~such~~
8 TO THE guest, boarder, lodger, or tenant. ~~, and such~~ THE lien
9 may be enforced in the manner ~~hereinafter~~ prescribed IN THIS
10 ACT.

11 (2) AS USED IN THIS SECTION, "BED AND BREAKFAST" MEANS A BED
12 AND BREAKFAST AS DEFINED IN SECTION 12901 OF THE PUBLIC HEALTH
13 CODE, ACT NO. 368 OF THE PUBLIC ACTS OF 1978, BEING SECTION
14 333.12901 OF THE MICHIGAN COMPILED LAWS.

15 Section 2. This amendatory act shall not take effect unless
