

# HOUSE BILL No. 4665

May 21, 1987, Introduced by Reps. Bartnik, Gagliardi, Alley, Allen, Connors, Trim, DeBeaussaert, Hickner, Hart, Barns, Weeks, Hertel, Stabenow, Sofio, Johnson, Pridnia, Giese, Gnodtke, Miller, Stacey, Sikkema, Willis Bullard, Law, Hoffman, Lynn Owen and Mathieu and referred to the Committee on Tourism and Recreation.

A bill to amend Act No. 230 of the Public Acts of 1972,  
entitled as amended

"State construction code act of 1972,"

as amended, being sections 125.1501 to 125.1531 of the Michigan  
Compiled Laws, by adding section 4b.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1       Section 1. Act No. 230 of the Public Acts of 1972, as  
2 amended, being sections 125.1501 to 125.1531 of the Michigan  
3 Compiled Laws, is amended by adding section 4b to read as  
4 follows:

5       SEC. 4B. (1) A BED AND BREAKFAST SHALL BE CONSIDERED UNDER  
6 THE CODE TO BE A PERMANENT RESIDENCE AND SHALL NOT BE TREATED AS  
7 A HOTEL OR OTHER FACILITY SERVING TRANSIENT TENANTS. THIS  
8 SECTION SHALL BE EFFECTIVE THROUGHOUT THE STATE WITHOUT LOCAL

1 MODIFICATION, NOTWITHSTANDING THE EXEMPTION PROVISIONS OF SECTION  
2 8.

3 (2) AS USED IN THIS SECTION, "BED AND BREAKFAST" MEANS THAT  
4 TERM AS DEFINED IN SECTION 12901 OF THE PUBLIC HEALTH CODE, ACT  
5 NO. 368 OF THE PUBLIC ACTS OF 1978, BEING SECTION 333.12901 OF  
6 THE MICHIGAN COMPILED LAWS.

7 Section 2. This amendatory act shall not take effect unless  
8 all of the following bills of the 84th Legislature are enacted  
9 into law:
