THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Section 1 of Act No. 119 of the Public Acts of

- 4 Sec. 1. As used in this act:
- 5 (a) "Axle" means any 2 or more load-carrying wheels mounted
- 6 in a single transverse vertical plane.
- 7 (b) "Commercial motor vehicle" means a road tractor, or a
- 8 truck tractor or a truck having more than 2 axles, if the road
- 9 tractor, or truck tractor or truck is propelled by motor fuel.

- (c) "Commercial motor vehicle" shall not include -either a
- 2 road tractor, OR a truck or truck tractor owned by a farmer
- 3 and used in connection with the farmer's farming operation and
- 4 not used for hire. COMMERCIAL MOTOR VEHICLE INCLUDES A ROAD
- 5 TRACTOR, OR A TRUCK OR TRUCK TRACTOR OWNED BY A FARMER AND USED
- 6 IN CONNECTION WITH THE FARMER'S FARMING OPERATION IF THE FARMER'S
- 7 FARMING OPERATION IS LOCATED IN A STATE WHICH DOES NOT EXEMPT

- (d) "Commissioner" means the state commissioner of revenue.
- (e) "Department" means the revenue division of the department of treasury.
- (f) "Motor carrier" means a person who operates or causes to

- (g) "Motor fuel" means diesel motor fuel as defined by Act
- 17 No. 150 of the Public Acts of 1927, as amended, being sections
- 18 207.101 to 207.194 of the Michigan Compiled Laws.
- (h) "Nonprofit private, parochial, denominational, or public
- 20 school, college, or university" means an elementary, secondary,
- 21 or postsecondary educational facility.
- (i) "Person" means a natural person, partnership, firm,
- 23 association, joint stock company, syndicate, or corporation, and
- 24 any receiver, trustee, conservator, or officer, other than a unit
- 25 of government, having jurisdiction and control of property by
- 26 virtue of law or by appointment of a court.

- 1 (j) "Public roads or highways" means a road, street, or
 2 place maintained by this state or a political subdivision of this
 3 state and generally open to use by the public as a matter of
 4 right for the purpose of vehicular travel, notwithstanding that
 5 they may be temporarily closed or travel restricted for the pur6 pose of construction, maintenance, repair, or reconstruction.
- 7 (k) "Road tractor" means a motor vehicle designed and used 8 for drawing other vehicles, but not constructed to carry any load 9 either independently or as a part of the weight of the vehicle or 10 load being drawn.
- 11 (1) "Truck" means a motor vehicle designed, used, or main12 tained primarily for the transportation of property.
- (m) "Truck tractor" means a motor vehicle designed and used
 14 primarily for drawing other vehicles and not constructed to carry
 15 a load other than a part of the weight of the vehicle and load
 16 being drawn.
