- 3 (3) THE DEPARTMENT SHALL INSURE THAT THE METHODS AND MATERI-
- 4 ALS PROPOSED AND USED BY A DISTRICT ARE THOSE CONSIDERED TO BE
- 5 EFFECTIVE AND HAVE THE LEAST POTENTIAL FOR HARM TO OTHER ORGAN-
- 6 ISMS AND PEOPLE. THE DEPARTMENT SHALL ADVISE THE BOARD OF TRUST-
- 7 EES AND THE PERSON IN CHARGE OF THE OPERATION OF A DISTRICT OF
- 8 THOSE METHODS AND MATERIALS RECOMMENDED FOR USE AND SHALL EXER-

- 9 FILED WITH THE COUNTY BOARD OF COMMISSIONERS TO TERMINATE THE
- 10 OPERATIONS OF THE DISTRICT. THE PETITION SHALL BE SIGNED BY AT
- 11 LEAST 8% OF THE REGISTERED VOTERS WITHIN THE BOUNDARIES OF THE
- 12 DISTRICT WHO CAST VOTES FOR GOVERNOR IN THE LAST GENERAL ELECTION
- 13 WITHIN THE DISTRICT.
- 14 (2) WITHIN 60 DAYS AFTER A PETITION IS RECEIVED, THE COUNTY
- 15 BOARD OF COMMISSIONERS SHALL GIVE NOTICE OF THE HOLDING OF A SPE-
- 16 CIAL ELECTION IN THE MANNER PROVIDED BY LAW.
- 17 (3) IF A MAJORITY OF VOTES CAST IN THE SPECIAL ELECTION IS
- 18 IN FAVOR OF TERMINATING THE DISTRICT, THE COUNTY BOARD OF COMMIS-
- 19 SIONERS SHALL TERMINATE THE OPERATIONS OF THE DISTRICT.
- 20 (4) THE COUNTY BOARD OF COMMISSIONERS SHALL NOT ENTERTAIN
- 21 PETITIONS FOR THE DISCONTINUANCE OF A MOSQUITO ABATEMENT DISTRICT
- 22 NOR HOLD A SPECIAL ELECTION UNDER THIS SECTION MORE THAN ONCE
- 23 EVERY 2 YEARS.
