- 1 Section 1. Section 803e of Act No. 300 of the Public Acts

- 4 to read as follows:
- 5 Sec. 803e. (1) A person who has been a prisoner of war may
- 6 make application to the secretary of state, for a special regis-

- 1 and shall have the words "prisoner of war" "EX-PRISONER OF WAR"
- 2 inscribed beneath the registration number.
- 3 (2) Application for a special registration plate shall be on
- 4 a form prescribed by the secretary of state, and shall be accom-
- 5 panied by any proof of the applicant having been a prisoner of
- 6 war which the secretary of state may require. The application
- 7 for a special registration plate shall also be accompanied with
- 8 payment of a \$5.00 service fee.
- 9 (3) Upon proper application and payment of the \$5.00 service
