

HOUSE BILL No. 5337

February 2, 1988, Introduced by Reps. Dunaskiss, Sparks, Honigman, Willis Bullard, Bandstra, Fitzgerald, Browne, DeBeaussaert, Ciaramitaro, Gubow and DeMars and referred to the Committee on Judiciary.

A bill to amend section 8123 of Act No. 236 of the Public Acts of 1961, entitled as amended
"Revised judicature act of 1961,"
as amended by Act No. 142 of the Public Acts of 1984, being section 600.8123 of the Michigan Compiled Laws.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Section 1. Section 8123 of Act No. 236 of the Public Acts
2 of 1961, as amended by Act No. 142 of the Public Acts of 1984,
3 being section 600.8123 of the Michigan Compiled Laws, is amended
4 to read as follows:

5 Sec. 8123. (1) The forty-third district consists of the
6 cities of Madison Heights, Ferndale, and Hazel Park, is a dis-
7 trict of the third class, and has 3 judges.

8 (2) The forty-fourth district consists of the city of Royal
9 Oak, is a district of the third class, and has 2 judges.

1 (3) The forty-fifth-a district consists of the city of
2 Berkley, is a district of the third class, and has 1 judge.

3 (4) The forty-fifth-b district consists of the cities of
4 Huntington Woods, Oak Park, and Pleasant Ridge and the township
5 of Royal Oak in the county of Oakland, is a district of the third
6 class, and has 2 judges.

7 (5) The forty-sixth district consists of the cities of
8 Southfield and Lathrup Village and the township of Southfield in
9 the county of Oakland, is a district of the third class, and has
10 3 judges.

11 (6) The forty-seventh district consists of the cities of
12 Farmington and Farmington Hills, is a district of the third
13 class, and has 2 judges.

14 (7) The forty-eighth district consists of the cities of
15 Birmingham, Bloomfield Hills, Sylvan Lake, Keego Harbor, and
16 Orchard Lake Village and the townships of Bloomfield and West
17 Bloomfield in the county of Oakland, is a district of the third
18 class, and has 3 judges.

19 (8) The fiftieth district consists of the city of Pontiac,
20 is a district of the third class, and has 4 judges.

21 (9) The fifty-first district consists of the township of
22 Waterford in the county of Oakland, is a district of the third
23 class, and has 2 judges.

24 (10) The fifty-second district consists of the county of
25 Oakland except the cities of Madison Heights, Ferndale, Hazel
26 Park, Royal Oak, Berkley, Huntington Woods, Oak Park, Pleasant
27 Ridge, Southfield, Lathrup Village, Farmington, Farmington Hills,

1 Northville, Sylvan Lake, Keego Harbor, Orchard Lake Village,
2 Birmingham, Bloomfield Hills, and Pontiac and the townships of
3 Royal Oak, Southfield, West Bloomfield, Bloomfield, and
4 Waterford, is a district of the second class, and is divided into
5 the following election divisions:

6 (a) The first division consists of the cities of Novi, South
7 Lyon, Wixom, and Walled Lake and the townships of Milford,
8 Highland, Rose, White Lake, Commerce, Lyon, and Novi and has 3
9 judges.

10 (b) The second division consists of the townships of
11 Springfield, Independence, Holly, Groveland, and Brandon and has
12 1 judge.

13 (c) The third division consists of the cities of Rochester,
14 Auburn Hills, and Lake Angelus and the townships of Oxford,
15 Addison, Orion, Oakland, and Avon and has 2 judges. SUBJECT TO
16 SECTION 8175, THE THIRD DIVISION OF THE FIFTY-SECOND DISTRICT MAY
17 HAVE 1 ADDITIONAL JUDGE EFFECTIVE JANUARY 1, 1989.

18 (d) The fourth division consists of the cities of Troy and
19 Clawson and has 3 judges.
