- (F) THE PUPIL HAS 1 OR MORE SIBLINGS WHO HAVE DROPPED OUT OF

- (G) THE PUPIL IS A PARENT.
- (H) THE PUPIL WAS PREVIOUSLY A SCHOOL DROPOUT.
- 14 (6) THE DEPARTMENT SHALL DEVELOP DEFINITIONS TO DETERMINE
- 15 WHETHER OR NOT A PUPIL MEETS THE CRITERIA SPECIFIED IN
