- 7 SEMESTER EACH SECONDARY SCHOOL TEACHER IN THE DISTRICT RECEIVE A
- 8 COPY OF THE OFFICIAL TRANSCRIPT OF EACH PUPIL THE TEACHER TAUGHT
- 9 THE PREVIOUS SEMESTER.

1 (2) THE BOARD OF A SCHOOL DISTRICT OR INTERMEDIATE SCHOOL

- 2 DISTRICT SHALL NOT PERMIT ANY BOARD MEMBER, SUPERINTENDENT,
