HOUSE BILL No. 5827

July 13, 1988, Introduced by Reps. Sitz and DeMars and referred to the Committee on Military and Veterans' Affairs.

A bill to require registration with the military selective service system by male persons as a condition of eligibility for state supported financial aid for higher educational expenses.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1. As used in this act:
- 2 (a) "Educational expenses" means housing, tuition, books,
- 3 fees, and other costs directly associated with attending an edu-
- 4 cational institution.
- 5 (b) "Educational institution" means a public or private com-
- 6 munity college, college, university, or vocational school within
- 7 this state offering a degree beyond the twelfth grade.

- 9 lowship, or other award for educational expenses, which is
- 10 conferred upon a male person enrolled or accepted at an
- 11 educational institution and is subsidized by state funds.

- (d) "Financial institution" means a state or nationally
 chartered bank, a state or federally chartered savings and loan
 association, or a state or federally chartered credit union.
- 4 (e) "Lender" means this state, or an educational or finan5 cial institution in this state, which makes loans for educational
 6 expenses.
- 7 (f) "Loan" means an advance of money for educational pur8 poses to a male person enrolled or accepted at an educational
 9 institution within this state, which loan is insured, reinsured,
 10 subsidized, or guaranteed by the state or an agency by the state,
 11 or which is insured, reinsured, subsidized, or guaranteed by the
 12 United States government or an agency of the United States gov13 ernment, or which is made by a lender.
- 14 (g) "Selective service system" means a military registration
 15 system established in accordance with the military selective
 16 service act, 62 Stat. 604, 50 U.S.C. App. 453.
- (h) "Statement of selective service status" means a state18 ment filed by a male person with a lender acknowledging that he
 19 has registered with the selective service system or that he is
 20 not required to register with the selective service system for 1
 21 or more of the following reasons:
- 22 (i) He is under 18 or over 26 years of age.
- (ii) He is on active duty with the armed forces of the 24 United States other than for training in a reserve or national 25 guard unit.

- 1 (iii) He is a nonimmigrant alien lawfully in the United
- 2 States in accordance with section 101(a)(15) of the immigration
- 3 and nationality act, 66 Stat. 163, 8 U.S.C. 1101, as amended.
- 4 (iv) He is not a citizen of the United States and is a per-
- 5 manent resident of the trust territory of the Pacific islands or
- 6 the northern Mariana islands.
- 7 Sec. 2. (1) A male person not less than 18 years of age nor
- 8 more than 26 years of age shall not be eligible to receive a loan
- 9 or financial assistance from a lender or an educational institu-
- 10 tion for educational expenses unless he has registered with the
- 11 selective service system.
- (2) Upon receipt of an application by a male person
- 13 described in subsection (1), for a loan or financial assistance,
- 14 the lender or educational institution shall require the male
- 15 person to file a statement of selective service status. The
- 16 lender or educational institution shall maintain a record of the
- 17 statement of selective service status of the male person and
- 18 shall forward a copy to the department of education.

- 20 receives a statement of selective service status from a male
- 21 person, certifying that the male person has registered with the
- 22 selective service system, the lender or educational institution
- 23 shall not require the male person to file any further statements
- 24 of selective service status.
- 25 (2) If a lender or educational institution receives a state-
- 26 ment of selective service status from a male person certifying
- 27 that he is not required to register with the selective service

- 1 system, the lender or educational institution shall require the
- 2 male person to file a new statement of selective service status
- 3 each time he seeks to apply for a loan or financial assistance
- 4 for educational expenses.
