## **HOUSE BILL No. 5938**

September 29, 1988, Introduced by Rep. Law and referred to the Committee on Labor.

A bill to amend section 5 of Act No. 1 of the Public Acts of the Extra Session of 1936, entitled as amended "Michigan employment security act," as amended by Act No. 164 of the Public Acts of 1983, being section 421.5 of the Michigan Compiled Laws.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Section 5 of Act No. 1 of the Public Acts of the
- 2 Extra Session of 1936, as amended by Act No. 164 of the Public

- 4 is amended to read as follows:
- 5 Sec. 5. (1) The -commission by affirmative vote of not less
- 6 than 3 of its members GOVERNOR shall appoint an administrative
- 7 officer, hereinafter referred to as the director, who shall serve
- 8 at the pleasure of the commission and shall GOVERNOR, act as
- 9 secretary of the commission, and -shall- perform other duties -as

1 shall be delegated by the commission. The director shall

- 2 receive an annual salary as established annually by the
- 3 legislature, and shall be entitled to the actual and necessary
- 4 expenses incurred in the discharge of his or her official duties,
- 5 to be paid from the administration fund. The director shall
- 6 devote his or her entire time to the duties of the office. The
- 7 director may appoint, with the approval of the commission,
- 8 employees and assistants as shall be necessary for the proper
- 9 exercise of the powers -hereby granted BY THIS ACT, and subject
- 10 to the approval of the commission, may delegate to those employ-
- 11 ees or assistants the authority as he or she considers reasonable
- 12 and necessary. Employees and assistants shall receive their
- 13 actual and necessary expenses incurred in the discharge of their
