"Michigan vehicle code,"

as amended by Act No. 150 of the Public Acts of 1988, being section 257.803e of the Michigan Compiled Laws.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Section 803e of Act No. 300 of the Public Acts
- 2 of 1949, as amended by Act No. 150 of the Public Acts of 1988,
- 3 being section 257.803e of the Michigan Compiled Laws, is amended
- 4 to read as follows:
- 5 Sec. 803e. (1) A person who has been a prisoner of war may
- 6 make application to the secretary of state for a special regis-
- 7 tration plate which shall be inscribed with special
- 8 identification numbers preceded by the letters " EX-POW" and

1 shall have the words " ex-prisoner of war" inscribed beneath the
2 registration number.

- 3 (2) A person who was a member of the armed services during
- 4 World War I may make application to the secretary of state for a
- 5 special registration plate, which shall be inscribed with special
- 6 identification numbers preceded by the letters "WWI" and shall
- 7 have the words "World War I veteran" inscribed beneath the regis-
- 8 tration number.
- 9 (3) A person who was a member of the armed services during
- 10 1941, stationed at a United States military or naval establish-
- 11 ment at Pearl Harbor in the Hawaiian islands, and who survived
- 12 the attack by Japan on Pearl Harbor on December 7, 1941 may make
- 13 application to the secretary of state for a special registration
- 14 plate, which shall be inscribed with special identification num-
- 15 bers and shall have the words "Pearl Harbor survivor" inscribed
- 16 beneath the registration number.
- 17 (4) A person who is a recipient of the purple heart medal
- 18 may make application to the secretary of state for a special reg-
- 19 istration plate which shall be inscribed with special identifica-
- 20 tion numbers and shall have the words "combat wounded veteran"
- 21 inscribed beneath the registration number. In addition, the spe-
- 22 cial registration plate described under this subsection shall be
- 23 inscribed with a vignette of the official purple heart medal.
- 24 (5) A PERSON WHO WAS A MEMBER OF THE ARMED SERVICES DURING
- 25 THE KOREAN WAR MAY MAKE APPLICATION TO THE SECRETARY OF STATE FOR
- 26 A SPECIAL REGISTRATION PLATE, WHICH SHALL BE INSCRIBED WITH

- (6) -(5)- Application for a special registration plate shall
- 4 be on a form prescribed by the secretary of state, and shall be
- 5 accompanied by any proof of the applicant having been a prisoner
- 6 of war, World War I veteran, Pearl harbor survivor, or recipient
- 7 of the purple heart medal which the secretary of state may
- 8 require. The application for a special registration plate shall
- 9 also be accompanied with payment of a \$5.00 service fee.
- 10 (7) <del>(6)</del> Upon proper application and payment of the \$5.00
- 11 service fee, the secretary of state shall issue 1 or more special
- 12 registration plates for each applicant for use on a passenger
- 13 vehicle. A person who is handicapped who makes application for a
- 14 special registration plate under this section and who makes pay-
- 15 ment of the \$5.00 service fee shall be issued a handicapper tab
- 16 as provided in section 803f for his or her special registration
- The secretary of state shall require the same proof that 17 plate.
- 18 the applicant is a handicapper as is required for issuance of a
- 19 permanent certificate of identification under section 675.
- 20 person shall be entitled to 1 special registration plate issued
- 21 under subsection (1) which shall be exempt from payment of the
- 22 tax provided in section 801. A person who is issued an addi-
- 23 tional special registration plate under subsection (1) shall be
- 24 assessed the applicable tax provided for in section 801.
- 25 person issued 1 or more special registration plates under
- 26 subsection (2), (3), or (4), OR (5) shall be assessed the
- 27 applicable tax provided in section 801.

- 1 (8) -(7) The use of a special registration plate on a
  2 vehicle other than the vehicle for which the plate is issued, or
  3 by a person who does not qualify under this section, is a
  4 misdemeanor.
- 5 (9) -(8)- The special registration plate issued under this 6 section shall expire on the birthday of the vehicle owner in a 7 year in which new plates are issued by the secretary of state. 8 Application for renewal of the special registration plate shall 9 be accompanied by a \$5.00 service fee. The applicant shall not 10 be required to furnish the proof provided in subsection -(5)-11 (6).
