THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 5 SEC. 36. (1) A FACILITY THAT CONDUCTS SPORTING EVENTS OR
- 6 OTHER SPECTATOR EVENTS FOR WHICH TICKETS ARE SOLD OR DISTRIBUTED
- 7 TO THE PUBLIC, HAS MORE THAN 1,000 SEATS AVAILABLE TO THE PUBLIC,
- 8 AND IS LICENSED TO SELL ALCOHOLIC LIQUOR FOR CONSUMPTION ON THE
- 9 PREMISES SHALL ESTABLISH A SEPARATE NONALCOHOLIC SEATING AREA OR

- 1 AREAS IN WHICH THE CONSUMPTION OF ALCOHOLIC LIQUOR IS NOT
- 2 ALLOWED. EACH NONALCOHOLIC SEATING AREA SHALL CONTAIN, AS NEAR
- 3 AS POSSIBLE, CONTIGUOUS SEATS. THE FACILITY SHALL MAKE IT A CON-
- 4 DITION OF ATTENDANCE BY TICKET HOLDERS THAT A TICKET HOLDER WILL
- 5 NOT POSSESS OR CONSUME ALCOHOLIC LIQUOR WHILE IN A NONALCOHOLIC
- 6 SEATING AREA.
- 7 (2) THE NONALCOHOLIC SEATING AREA SHALL CONSIST OF NOT LESS
- 8 THAN 25% OF THE TOTAL NUMBER OF SEATS AVAILABLE TO THE PUBLIC IN
- 9 THE FACILITY, NOT INCLUDING SEPARATE CLUB OR DINING ROOM SEATING,
- 10 PRIVATE ROOMS SEPARATED BY SOLID PARTITIONS FROM OTHER SPECTATOR
- 11 SEATING, OR SEATS RESERVED FOR MEMBERS OF THE PRESS. IF THE
- 12 TICKETS SOLD TO THE PUBLIC FOR A SPORTING OR OTHER SPECTATOR
- 13 EVENT ARE ALL SOLD AT THE SAME PRICE, THE FACILITY MAY ESTABLISH
- 14 A SINGLE NONALCOHOLIC SEATING SECTION MEETING THE 25% REQUIREMENT
- 15 OF THIS SUBSECTION. IF THE TICKETS SOLD TO THE PUBLIC FOR A
- 16 SPORTING OR OTHER SPECTATOR EVENT ARE SOLD AT DIFFERENT PRICES,
- 17 THE FACILITY SHALL ESTABLISH A SEPARATE NONALCOHOLIC SEATING AREA
- 18 AVAILABLE TO THE TICKET HOLDERS OF EACH PRICE OF TICKET, WITH 25%
- 19 OF THE SEATS AVAILABLE TO THE HOLDERS OF EACH PRICE OF TICKET
- 20 BEING RESERVED AS NONALCOHOLIC SEATING AREAS.
- 21 (3) A PERSON WHO POSSESSES OR CONSUMES ALCOHOLIC LIQUOR IN A
- 22 NONALCOHOLIC SEATING AREA ESTABLISHED UNDER THIS SECTION IS
- 23 GUILTY OF A MISDEMEANOR, PUNISHABLE AS PROVIDED IN SECTION 50.
- 24 (4) THE COMMISSION SHALL PROMULGATE RULES TO IMPLEMENT THIS
- 25 SECTION, INCLUDING RULES THAT REQUIRE NOTICE TO TICKET HOLDERS OF
- 26 THE PROVISIONS OF THIS SECTION, AND PROVIDING CONSPICUOUS WARNING
- 27 OF THE PENALTY PROVIDED IN SUBSECTION (3).
