THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Section 1. Act No. 240 of the Public Acts of 1943, as

- 3 Laws, is amended by adding section 17g to read as follows:
- 4 SEC. 17G. (1) A MEMBER OF THIS RETIREMENT SYSTEM WHO WAS
- 5 TRANSFERRED FROM THE EMPLOY OF WAYNE COUNTY TO THE EMPLOY OF THE
- 6 STATE AS A RESULT OF THE TRANSFER OF THE WAYNE COUNTY PSYCHIATRIC
- 7 HOSPITAL TO THE STATE, AND WHO BECAME A MEMBER OF THIS RETIREMENT
- 8 SYSTEM AS A DIRECT RESULT OF THIS TRANSFER, MAY ELECT TO PURCHASE
- 9 SERVICE CREDIT FOR ALL FULL-TIME SERVICE FOR WHICH THE MEMBER

- 1 MADE CONTRIBUTIONS TO THE WAYNE COUNTY RETIREMENT SYSTEM FOR

- 16 (2) SERVICE CREDIT PURCHASED UNDER THIS SECTION SHALL NOT BE
- 17 CREDITABLE TOWARD RETIREMENT UNDER THIS ACT IF THE MEMBER IS OR
- 18 WILL BE RECEIVING A PENSION OR ANNUITY FOR THE SAME SERVICE FROM
- 19 ANOTHER RETIREMENT SYSTEM.
