THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 5 SEC. 21794. (1) EXCEPT AS OTHERWISE PROVIDED IN
- 6 SUBSECTION (6), A NURSING HOME SHALL ADOPT AND IMPLEMENT A
- 7 SHORT-TERM TRAINING PROGRAM FOR NURSE AIDES THAT COMPLIES WITH
- 8 THIS SECTION AND RULES PROMULGATED PURSUANT TO THIS SECTION.

- 1 (2) THE TRAINING PROGRAM SHALL INCLUDE, AT A MINIMUM, THE 2 FOLLOWING:
- 3 (A) AN EXAMINATION OF THE PROBLEM OF ELDER ABUSE, NEGLECT,
- 4 AND EXPLOITATION OF THE ELDERLY.
- 5 (B) INSTRUCTION ON THE DEBILITATING PSYCHOLOGICAL AND PHYSI-
- 6 CAL EFFECTS OF AGING, ILLNESS, AND INSTITUTIONALIZATION ON THE
- 7 ELDERLY.
- 8 (C) INSTRUCTION ON STRESS MANAGEMENT, INCLUDING SPECIFIC

- 15 (4) A CURRENT EMPLOYEE IS REQUIRED TO RECEIVE 4 HOURS OF

- 1 (7) DURING THE ANNUAL LICENSING INSPECTION THE DEPARTMENT
- 2 SHALL, AND DURING OTHER INSPECTIONS THE DEPARTMENT MAY, CONDUCT
- 3 RANDOM COMPETENCY EXAMINATIONS TO DETERMINE WHETHER THE REQUIRE-
- 4 MENTS OF THIS SECTION ARE BEING MET. THE DEPARTMENT SHALL
- 5 PROMULGATE RULES TO ADMINISTER THIS SUBSECTION.
- 6 (8) FOR PURPOSES OF THIS SECTION, "NURSE AIDE" MEANS AN
- 7 UNLICENSED NURSING HOME EMPLOYEE WHO PROVIDES NURSING CARE TO
- 8 PATIENTS OR WHO, IN THE REGULAR COURSE OF HIS OR HER DUTIES,
- 9 ENGAGES IN PHYSICAL CONTACT WITH PATIENTS.
