All land not withheld from sale and not held 3 by a city or village shall be offered for sale by the director, 4 at a price to be determined by the director, in accordance with 5 Act No. 21 of the Public Acts of 1873, as amended, being sections 6 322.261 to -322.264 322.266 of the Michigan Compiled Laws. 7 bid shall not be accepted for less than the minimum price set by 8 the director. If no bids are received or accepted by the direc-9 tor of the department of natural resources, the director may sell 10 the land to a person applying for the purchase of the land at a 11 price not less than the minimum price affixed by the director. 12 The proceeds of the sale, after deducting costs paid by the 13 department of natural resources for maintaining the land in con-14 dition to protect the public health and safety, shall be 15 accounted for to the state, county, township, and school district 16 in which the land is situated, pro rata according to their sev-17 eral interests in the land arising from the nonpayment of taxes 18 and special assessments on the land as such interest appears in 19 the offices of the state, county, city, and village treasurers. 20 A person who purchases land under this section shall, in addition 21 to paying the purchase price, pay to the state a fee of \$10.00 22 per parcel of land purchased plus 5% of the purchase price. 23 \$10.00 charge and 5% of the purchase price shall be deposited in 24 the state treasury to the credit of the delinquent property tax 25 administration fund.
