## **HOUSE BILL No. 4218**

February 7, 1991, Introduced by Rep. Alley and referred to the Committee on Conservation, Recreation and Environment.

A bill to amend section 3 of Act No. 94 of the Public Acts of 1988, entitled

"Game and fish lifetime license trust fund,"
as amended by Act No. 234 of the Public Acts of 1989, being section 316.1003 of the Michigan Compiled Laws.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Section 3 of Act No. 94 of the Public Acts of
- 2 1988, as amended by Act No. 234 of the Public Acts of 1989, being
- 3 section 316.1003 of the Michigan Compiled Laws, is amended to
- 4 read as follows:
- 5 Sec. 3. (1) From March 1, 1989 to February 28, 1990, cer-
- 6 tain lifetime hunting or fishing licenses may be purchased by a
- 7 resident of this state as provided in this act, for the following
- 8 fees:

- 1 (a) The fee for a lifetime small game license, equivalent to
- 2 the license available annually pursuant to section 305 of the
- 3 hunting and fishing license act, Act No. 86 of the Public Acts of
- 4 1980, being section 316.305 of the Michigan Compiled Laws, shall
- 5 be \$220.00.
- 6 (b) The fee for a lifetime firearm deer license, equivalent
- 7 to the license available annually to take ! deer in a season pur-
- 8 suant to section 308 of the hunting and fishing license act, Act
- 9 No. 86 of the Public Acts of 1980, being section 316.308 of the
- 10 Michigan Compiled Laws, shall be \$285.00.
- (c) The fee for a lifetime bow and arrow license, equivalent
- 12 to the license available annually to take 1 deer in a season pur-
- 13 suant to section 309 of the hunting and fishing license act, Act
- 14 No. 86 of the Public Acts of 1980, being section 316.309 of the
- 15 Michigan Compiled Laws, shall be \$285.00.
- (d) The fee for a lifetime sportsperson license, equivalent
- 17 to the license available pursuant to section 304a of the hunting
- 18 and fishing license act, Act No. 86 of the Public Acts of 1980,
- 19 being section 316.304a of the Michigan Compiled Laws, shall be
- 20 \$1,000.00.
- (e) The fee for a comprehensive lifetime hunting and fishing
- 22 license is \$1,025.00 and shall include all of the following:
- 23 (i) Resident small game license.
- 24 (ii) Resident firearm deer license.
- 25 (iii) Resident bow and arrow deer license.
- 26 (iv) Resident fish license.

- 1 (v) Resident trout and salmon stamp.
- 2 (vi) Resident bear license.
- 3 (vii) Waterfowl hunting stamp.
- 4 (viii) Resident fur harvester's license.
- 5 (f) The fee for a lifetime fishing license, equivalent to
- 6 the resident annual fishing license issued pursuant to
- 7 section 315 of the hunting and fishing license act, Act No. 86 of
- 8 the Public Acts of 1980, being section 316.315 of the Michigan
- 9 Compiled Laws, shall be \$220.00.
- 10 (g) The fee for a lifetime trout and salmon license, equiva-
- 11 lent to the annual trout and salmon stamp issued pursuant to
- 12 section 315 of the hunting and fishing license act, Act No. 86 of
- 13 the Public Acts of 1980, being section 316.315 of the Michigan
- 14 Compiled Laws, shall be \$220.00.
- (2) A lifetime license issued pursuant to this section shall
- 16 allow the holder of that license, throughout his or her lifetime,
- 17 the same privileges, responsibilities, and duties as would the
- 18 equivalent annual license or stamp issued pursuant to the hunting
- 19 and fishing license act, Act No. 86 of the Public Acts of 1980,
- 20 being sections 316.101 to 316.902 of the Michigan Compiled Laws.
- 21 However, a lifetime license issued under this act does not guar-
- 22 antee the holder of that license the right to take game except in
- 23 compliance with harvest regulations and license and permit condi-
- 24 tions established for that species by the commission of -natural
- 25 resources CONSERVATION AND RECREATION.
- 26 (3) A lifetime license issued to a person who is a resident
- 27 of this state at the time the license is purchased shall continue

- 1 to be valid even if the holder of that license becomes a
  2 nonresident.
- 3 (4) A person who holds a lifetime sportsperson license may
- 4 purchase a comprehensive lifetime hunting and fishing license for
- 5 \$25.00.
- 6 Section 2. This amendatory act shall not take effect unless
- 7 all of the following bills of the 86th Legislature are enacted
- 8 into law:
