March 5, 1991, Introduced by Reps. Niederstadt, Bartnik, Pitoniak, Byrum, Baade, Dobronski, McNutt, Anthony, Middaugh and Dalman and referred to the Committee on Towns and Counties.

A bill to amend the title and sections 1, 2, and 3 of Act No. 105 of the Public Acts of 1964, entitled

"An act to provide for photostating, photographing, microphotographing or filming of records of the state, political subdivisions thereof and municipal courts of record; and to provide for the use thereof as evidence,"

being sections 691.1101, 691.1102, and 691.1103 of the Michigan Compiled Laws.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. The title and sections 1, 2, and 3 of Act
- 2 No. 105 of the Public Acts of 1964, being sections 691.1101,
- 3 691.1102, and 691.1103 of the Michigan Compiled Laws, are amended
- 4 to read as follows:

- 19 Sec. 3. Photographs, microphotographs or films A
- 20 REPRODUCTION of a record -thus IN A MEDIUM PURSUANT TO THE
- 21 RECORDS MEDIA ACT OR A REPRODUCTION CONSISTING OF A PRINTOUT OR
- 22 OTHER OUTPUT READABLE BY SIGHT FROM SUCH A MEDIUM prepared under
- 23 this or any other law shall have HAS the same force and
- 24 effect as the originals thereof would have had, ORIGINAL and
- 25 shall be treated as originals AN ORIGINAL for the purpose of
- 26 admissibility in evidence. Duly A DULY certified or
- 27 authenticated -copies of such photographs, microphotographs or

- 1 films COPY OF THE REPRODUCTION shall be admitted in evidence
- 2 equally with the original photographs, microphotographs or
- 3 films REPRODUCTION.
- 4 Section 2. This amendatory act shall not take effect unless
- 5 Senate Bill No. ____ or House Bill No. 4438 (request
- 6 no. 01788'91) of the 86th Legislature is enacted into law.
