- 1 Section 1. The title of Act No. 328 of the Public Acts of

- 6 An act to revise, consolidate, codify and add to the stat-

- 4 (C) COMMITS A VIOLATION OF THIS ACT RESULTING IN DAMAGE TO
- 5 THE ROOM OR ITS FURNISHINGS.
- (3) IN A CASE INVOLVING DAMAGE TO THE ROOM, A COURT MAY
- 7 ORDER THE INDIVIDUAL TO PAY RESTITUTION WHICH MAY INCLUDE THE
- 8 REASONABLE LOSS OF REVENUE RESULTING FROM THE INABILITY TO RENT
- 9 OR LEASE THE ROOM DURING THE PERIOD OF TIME THE ROOM IS BEING
- 10 REPAIRED.
- 11 (4) IN A CASE INVOLVING DAMAGE TO THE ROOM, THE COURT SHALL
- 12 DISMISS A CRIMINAL ACTION FOR VIOLATION OF THIS SECTION IF THE
- 13 DEFENDANT PAYS THE RESTITUTION ALLOWABLE UNDER THIS SECTION AS
- 14 DEMANDED BY THE OWNER OR OPERATOR OF THE HOTEL OR BED AND
- 15 BREAKFAST.
- 16 (5) THE OWNER OR OPERATOR OF THE HOTEL OR BED AND BREAKFAST
- 17 SHALL POST A COPY OF THIS SECTION IN A CONSPICUOUS PLACE ADJACENT
- 18 TO THE SITE OF REGISTRATION FOR A ROOM OR INSIDE THE ROOM.
- 19 (6) A LAW ENFORCEMENT AGENCY RECEIVING WRITTEN OR ORAL NOTI-
- 20 FICATION OF A VIOLATION OF THIS SECTION SHALL RESPOND TO THAT
- 21 NOTIFICATION.
