## **HOUSE BILL No. 5887**

June 1, 1992, Introduced by Reps. Baade, Bennane, Gire, Berman, Bartnik, DeMars, Anthony, Olshove, Yokich and Bodem and referred to the Committee on Social Services and Youth.

A bill to amend sections 10 and 23 of Act No. 295 of the Public Acts of 1982, entitled as amended "Support and visitation enforcement act," section 23 as amended by Act No. 210 of the Public Acts of 1985, being sections 552.610 and 552.623 of the Michigan Compiled Laws; and to add section 7a.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Sections 10 and 23 of Act No. 295 of the Public
- 2 Acts of 1982, section 23 as amended by Act No. 210 of the Public
- 3 Acts of 1985, being sections 552.610 and 552.623 of the Michigan
- 4 Compiled Laws, are amended and section 7a is added to read as
- 5 follows:
- 6 SEC. 7A. IN THE CASE OF A PAYER SUBJECT TO A SUPPORT ORDER
- 7 WHO IS AT LEAST 3 MONTHS IN ARREARS OF SUPPORT AND WHO IS
- 8 DETERMINED BY THE OFFICE OF THE FRIEND OF THE COURT TO BE THE

- 1 HOLDER OF AN OCCUPATIONAL LICENSE, REGISTRATION, OR CERTIFICATE
- 2 ISSUED BY THE STATE OF MICHIGAN, THE OFFICE OF THE FRIEND OF THE
- 3 COURT SHALL SEND A NOTICE OF ARREARAGE TO THE STATE BOARD,
- 4 AGENCY, OR DEPARTMENT HAVING REGULATORY AUTHORITY AND SHALL
- 5 REQUEST THAT A HEARING BE HELD REGARDING THE IMPOSITION OF A
- 6 SANCTION AGAINST THE LICENSE, REGISTRATION, OR CERTIFICATE OF THE 7 PAYER.
- 8 Sec. 10. (1) The payer shall give to the office of the
- 9 friend of the court at the time the order of income withholding
- 10 is issued the name and address of his or her employer. The payer
- 11 shall immediately give to the office of the friend of the court
- 12 notice of the name and address of any subsequent employer.
- 13 (2) THE PAYER SHALL GIVE TO THE OFFICE OF THE FRIEND OF THE
- 14 COURT AT THE TIME AN ORDER OF INCOME WITHHOLDING OR SUPPORT ORDER
- 15 IS ISSUED INFORMATION REGARDING THE HOLDING OF ANY OCCUPATIONAL
- 16 LICENSE, REGISTRATION, OR CERTIFICATE ISSUED BY THE STATE OF
- 17 MICHIGAN. THE PAYER SHALL IMMEDIATELY GIVE THE OFFICE OF THE
- 18 FRIEND OF THE COURT NOTICE OF ANY CHANGE IN HIS OR HER STATUS AS
- 19 AN INDIVIDUAL WHOSE OCCUPATION IS LICENSED, REGISTERED, CERTIFI-
- 20 CATED, OR OTHERWISE REGULATED BY THE STATE OF MICHIGAN.
- 21 Sec. 23. (1) The EXCEPT IN THE CASE OF A PAYER WHOSE
- 22 OCCUPATIONAL LICENSE, REGISTRATION, OR CERTIFICATE IS NECESSARY
- 23 FOR THE PRACTICE OF A PARTICULAR OCCUPATION OR BUSINESS, THE
- 24 source of income shall not use an order of income withholding as
- 25 a basis for refusing to employ, discharging, or taking any disci-
- 26 plinary action or imposing any penalty against a payer.

        (2) A source of income who refuses to employ, discharges,
 2 disciplines, or penalizes a payer in violation of this section is
 3 guilty of a misdemeanor, punishable by a fine of not more than
 4 $500.00, and shall be required to make full restitution to the
 5 aggrieved payer, including reinstatement and back pay.
