

HOUSE BILL No. 5892

June 3, 1992, Introduced by Reps. Joe Young, Sr., Richard A. Young and Johnson and referred to the Committee on Judiciary.

A bill to amend Act No. 236 of the Public Acts of 1961, entitled as amended "Revised judicature act of 1961," as amended, being sections 600.101 to 600.9947 of the Michigan Compiled Laws, by adding sections 5756a and 8374.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Section 1. Act No. 236 of the Public Acts of 1961, as
2 amended, being sections 600.101 to 600.9947 of the Michigan
3 Compiled Laws, is amended by adding sections 5756a and 8374 to
4 read as follows:

5 SEC. 5756A. (1) THE CLERK OF THE DISTRICT COURT IN THE
6 THIRTY-SIXTH DISTRICT SHALL COLLECT THE FEE PRESCRIBED IN
7 SECTION 8374 FOR EACH MOTION FILED IN A PROCEEDING UNDER THIS
8 CHAPTER OR CHAPTER 57A.

1 (2) THE STATE OR A POLITICAL SUBDIVISION OF THIS STATE SHALL
2 NOT BE REQUIRED TO PAY A MOTION FEE UNDER SUBSECTION (1).

3 (3) ON OR BEFORE THE FIFTEENTH DAY OF EACH MONTH, THE FEES
4 COLLECTED UNDER SUBSECTION (1) SHALL BE TRANSMITTED TO THE STATE
5 TREASURER. THE STATE TREASURER SHALL DEPOSIT THE FEES IN THE
6 FUND CREATED IN SECTION 8380.

7 SEC. 8374. (1) THE CLERK OF THE DISTRICT COURT IN THE
8 THIRTY-SIXTH DISTRICT SHALL COLLECT A \$10.00 FEE FOR EACH MOTION
9 FILED IN A CIVIL ACTION OR CIVIL INFRACTION ACTION.

10 (2) THE STATE OR A POLITICAL SUBDIVISION OF THIS STATE SHALL
11 NOT BE REQUIRED TO PAY A MOTION FEE UNDER SUBSECTION (1) IN A
12 CIVIL INFRACTION ACTION.

13 (3) ON OR BEFORE THE FIFTEENTH DAY OF EACH MONTH, THE FEES
14 COLLECTED UNDER SUBSECTION (1) SHALL BE TRANSMITTED TO THE STATE
15 TREASURER. THE STATE TREASURER SHALL DEPOSIT THE FEES IN THE
16 FUND CREATED IN SECTION 8380.

17 (4) THIS SECTION DOES NOT APPLY TO PROCEEDINGS UNDER
18 CHAPTER 43 OR 84.
