

# HOUSE BILL No. 5893

June 3, 1992, Introduced by Reps. Wallace, Richard A. Young and Johnson and referred to the Committee on Judiciary.

A bill to amend section 8381 of Act No. 236 of the Public Acts of 1961, entitled as amended "Revised judicature act of 1961," being section 600.8381 of the Michigan Compiled Laws; and to add section 8380.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1       Section 1. Section 8381 of Act No. 236 of the Public Acts  
2 of 1961, being section 600.8381 of the Michigan Compiled Laws, is  
3 amended and section 8380 is added to read as follows:

4       SEC. 8380. A RESTRICTED FUND IS CREATED IN THE STATE  
5 TREASURY. THE MONEY IN THE FUND SHALL BE USED FOR THE EXPENSES  
6 OF THE DISTRICT COURT IN THE THIRTY-SIXTH DISTRICT.

7       Sec. 8381. When fines and costs are assessed by a  
8 magistrate, a traffic bureau, or a judge of the district court,  
9 not less than \$5.00 shall be assessed as costs and collected for

1 each conviction or civil infraction determination and each guilty  
2 plea or civil infraction admission except for parking  
3 violations. Of the costs assessed and collected, for each con-  
4 viction or civil infraction determination and each guilty plea or  
5 civil infraction admission, \$5.00 shall be paid to the clerk of  
6 the district court who, on or before the fifteenth of each month,  
7 shall transmit it to the state treasurer. The state treasurer  
8 shall deposit 6% of the costs collected to the legislative  
9 retirement fund created by THE MICHIGAN LEGISLATIVE RETIREMENT  
10 SYSTEM ACT, Act No. 261 of the Public Acts of 1957, as amended,  
11 being sections 38.1001 to 38.1060 of the Michigan Compiled Laws;  
12 9% of the costs collected to the judges' retirement fund created  
13 by THE JUDGES' RETIREMENT ACT, Act No. 198 of the Public Acts of  
14 1951, as amended, BEING SECTIONS 38.801 TO 38.831 OF THE MICHIGAN  
15 COMPILED LAWS; and shall deposit the balance of the costs col-  
16 lected AS FOLLOWS:

17 (A) EXCEPT AS PROVIDED IN SUBDIVISION (B), THE BALANCE OF  
18 THE COSTS SHALL BE DEPOSITED in the general fund.

19 (B) IN THE DISTRICT COURT IN THE THIRTY-SIXTH DISTRICT, THE  
20 BALANCE OF THE COSTS SHALL BE TRANSMITTED TO THE STATE  
21 TREASURER. THE STATE TREASURER SHALL DEPOSIT THE BALANCE OF THE  
22 COSTS IN THE FUND CREATED IN SECTION 8380.
