

HOUSE BILL No. 6157

September 30, 1992, Introduced by Reps. Owen, Yokich, Perry Bullard, Walberg, Profit, Gubow and Wallace and referred to the Committee on Insurance.

A bill to amend Act No. 368 of the Public Acts of 1978,
entitled as amended

"Public health code,"

as amended, being sections 333.1101 to 333.25211 of the Michigan
Compiled Laws, by adding sections 16309 and 20195.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Section 1. Act No. 368 of the Public Acts of 1978, as
2 amended, being sections 333.1101 to 333.25211 of the Michigan
3 Compiled Laws, is amended by adding sections 16309 and 20195 to
4 read as follows:

5 SEC. 16309. THE DEPARTMENT OF PUBLIC HEALTH SHALL DISTRIB-
6 UTE TO ALL STATE LICENSED HEALTH PROFESSIONALS THE NOTICE CON-
7 TAINING INFORMATION ABOUT SELF-FUNDED HEALTH INSURANCE PLANS THAT
8 THE DEPARTMENT RECEIVES PURSUANT TO SECTION 235 OF THE INSURANCE
9 CODE OF 1956, ACT NO. 218 OF THE PUBLIC ACTS OF 1956, BEING

1 SECTION 500.235 OF THE MICHIGAN COMPILED LAWS. THE DEPARTMENT OF
2 PUBLIC HEALTH SHALL ADVISE EACH HEALTH CARE PROFESSIONAL THAT THE
3 NOTICE RECEIVED PURSUANT TO THIS SECTION IS A CONSUMER ASSISTANCE
4 NOTICE AND SHALL BE MADE AVAILABLE TO ALL OF THE HEALTH CARE
5 PROFESSIONAL'S PATIENTS.

6 SEC. 20195. THE DEPARTMENT SHALL DISTRIBUTE TO ALL STATE
7 LICENSED HEALTH FACILITIES THE NOTICE CONTAINING INFORMATION
8 ABOUT SELF-FUNDED HEALTH INSURANCE PLANS THAT THE DEPARTMENT
9 RECEIVES PURSUANT TO SECTION 235 OF THE INSURANCE CODE OF 1956,
10 ACT NO. 218 OF THE PUBLIC ACTS OF 1956, BEING SECTION 500.235 OF
11 THE MICHIGAN COMPILED LAWS. THE DEPARTMENT SHALL ADVISE EACH
12 HEALTH FACILITY THAT THE NOTICE RECEIVED PURSUANT TO THIS SECTION
13 IS A CONSUMER ASSISTANCE NOTICE AND SHALL BE MADE AVAILABLE TO
14 ALL OF THE HEALTH FACILITY'S PATIENTS.

15 Section 2. This amendatory act shall not take effect unless
16 Senate Bill No. _____ or House Bill No. 6158 (request
17 no. 06286'92) of the 86th Legislature is enacted into law.
