A bill to amend Act No. 125 of the Public Acts of 1963, entitled

"An act to provide for the incorporation, supervision and regulation of nonprofit dental care corporations; to prescribe the functions of the commissioner of insurance as to such corporations; and to prescribe penalties for violations of this act,"

as amended, being sections 550.351 to 550.373 of the Michigan Compiled Laws, by adding section 18a.

- 7 AND PROVIDED UNDER THE APPLICABLE CONTRACT. IF NOT PAID ON A

- 1 TIMELY BASIS, BENEFITS PAYABLE TO A MEMBER OR DENTIST SHALL BEAR
- 2 SIMPLE INTEREST FROM A DATE 30 DAYS AFTER A SATISFACTORY CLAIM
- 3 FORM WAS RECEIVED BY THE DENTAL CARE CORPORATION, AT A RATE OF
- 4 18% INTEREST PER ANNUM. THE INTEREST SHALL BE PAID IN ADDITION
- 5 TO, AND AT THE TIME OF PAYMENT OF, THE CLAIM.
- (2) A DENTAL CARE CORPORATION SHALL SPECIFY IN WRITING THE
- 7 MATERIALS THAT CONSTITUTE A SATISFACTORY CLAIM FORM NOT LATER
- 8 THAN 15 DAYS AFTER RECEIPT OF A CLAIM, UNLESS THE CLAIM IS SET-
- 9 TLED WITHIN 15 DAYS. IF A CLAIM FORM IS NOT SUPPLIED AS TO THE
- 10 ENTIRE CLAIM, THE AMOUNT SUPPORTED BY THE CLAIM FORM SHALL BE
- 11 CONSIDERED TO BE PAID ON A TIMELY BASIS IF PAID WITHIN 30 DAYS
- 12 AFTER RECEIPT OF THE CLAIM FORM BY THE CORPORATION.
