- 5 SEC. 1295. (1) EXCEPT AS OTHERWISE PROVIDED IN THIS SEC-
- 6 TION, A PERSON WHO KNOWINGLY OR INTENTIONALLY BY FORCE OR DURESS
- 7 CAUSES ANOTHER PERSON TO COMMIT SUICIDE IS GUILTY OF MURDER,
- 8 PUNISHABLE AS PROVIDED IN SECTION 316 OR 317 OF THE MICHIGAN

- 24 THE MICHIGAN COMPILED LAWS, IS NOT SUICIDE OR ASSISTANCE TO SUI-
- 25 CIDE UNDER THIS SECTION.
- 26 (5) ADMINISTERING MEDICATIONS OR PROCEDURES THAT MAY HASTEN
- 27 OR INCREASE THE RISK OF DEATH TO RELIEVE A PERSON'S PAIN OR

- 1 DISCOMFORT IS NOT SUICIDE OR ASSISTANCE TO SUICIDE UNDER THIS
- 2 SECTION UNLESS THE MEDICATIONS OR PROCEDURES ARE KNOWINGLY AND
- 3 INTENTIONALLY ADMINISTERED TO CAUSE DEATH.
