## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Act No. 328 of the Public Acts of 1931, as

- 3 Laws, is amended by adding section 472 to read as follows:
- 4 SEC. 472. (1) IN ORDER TO REDUCE LITTER AND TO PROTECT THE
- 5 PRIVACY OF INDIVIDUALS IN PUBLIC PLACES, AND BECAUSE THE STATE
- 6 PROHIBITS THE USE OF TOBACCO PRODUCTS BY MINORS AND THE FURNISH-
- 7 ING OF TOBACCO PRODUCTS TO MINORS, AND BECAUSE THE ENFORCEMENT OF
- 8 AN AGE-RELATED RESTRICTION ON THE DISTRIBUTION OF TOBACCO
- 9 PRODUCTS AT NO COST OR NOMINAL COST IS IMPRACTICAL AND

- 1 INEFFECTIVE, IT IS THE INTENT OF THE LEGISLATURE TO CONTROL THE
- 2 DISTRIBUTION OF TOBACCO PRODUCTS AND DISCOURAGE ILLEGAL ACTIVITY
- 3 BY PROHIBITING THE DISTRIBUTION OF TOBACCO PRODUCTS AT NO COST OR
- 4 NOMINAL COST AS PROVIDED IN THIS SECTION.
- 5 (2) EXCEPT AS OTHERWISE PROVIDED IN SUBSECTION (4), A PERSON

- 20 (7) A PERSON WHO VIOLATES SUBSECTION (3) IS GUILTY OF A
- 21 FELONY PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 1 YEAR OR A
- 22 FINE OF NOT MORE THAN \$1,000.00, OR BOTH.
- 23 (8) AS USED IN THIS SECTION:
- 24 (A) "DELIVER" MEANS THE ACTUAL OR ATTEMPTED TRANSFER OF
- 25 TOBACCO PRODUCTS FROM 1 PERSON TO ANOTHER PERSON.
- 26 (B) "TOBACCO PRODUCT" MEANS TOBACCO PREPARED FOR USE IN
- 27 SMOKING, CHEWING, OR AS SNUFF.
