THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Sections 1233 and 1531 of Act No. 451 of the
- 2 Public Acts of 1976, section 1233 as amended by Act No. 25 of the
- 3 Public Acts of 1990 and section 1531 as amended by Act No. 267 of
- 4 the Public Acts of 1986, being sections 380.1233 and 380.1531 of
- 5 the Michigan Compiled Laws, are amended to read as follows:
- 6 Sec. 1233. (1) Except as provided in subsection (3) and
- 7 section 1233b, the board of a school district or intermediate

- 1 school district shall not permit a teacher who does not hold a
- 2 valid teaching certificate to teach in a grade or department of
- 3 the school, A TEACHER WITHOUT AN ELEMENTARY FOREIGN LANGUAGE
- 4 ENDORSEMENT BY THE STATE BOARD TO TEACH A FOREIGN LANGUAGE IN AN
- 5 ELEMENTARY GRADE, or a teacher without -an- A COUNSELING endorse-
- 6 ment by the state board to serve in a counseling role as the role
- 7 is defined by the state board.
- 8 (2) The intermediate superintendent shall notify immediately
- 9 the state board of the names of noncertificated teachers and the
- 10 names of nonendorsed teachers TEACHING A FOREIGN LANGUAGE IN AN
- 11 ELEMENTARY GRADE OR serving in counseling roles, the employing
- 12 district, and the amount of time the noncertificated and nonen-
- 13 dorsed teachers were employed.
- 14 (3) The board of a school district or intermediate school
- 15 district may renew through June 30, 1995 an annual vocational
- 16 authorization of a noncertificated vocational teacher who is
- 17 employed by the district or intermediate school district on June
- 18 1, 1987, even if a certificated teacher is available for hire, if
- 19 both of the following conditions are met:
- (a) The noncertificated teacher is annually and continually
- 21 enrolled and completing credit in an approved vocational teacher
- 22 preparation program leading to vocational certification.
- 23 (b) The noncertificated teacher has a planned vocational
- 24 teacher preparation program leading to vocational certification
- 25 on file with the employing school district or intermediate school
- 26 district, his or her teacher preparation institution, and the
- 27 department of education.

- 1 (4) A vocational teacher preparation institution shall
- 2 utilize the employment experience of an annually authorized
- 3 teacher for the purpose of waiving student teaching as a require-
- 4 ment for vocational certification if the annually authorized
- 5 teacher is supervised by the teacher preparation institution.
- 6 (5) All vocational education teachers certified after
- 7 June 1, 1995 shall pass a competency test.
- 8 Sec. 1531. (1) Except as provided in this section, the
- 9 state board shall determine the requirements for and issue all
- 10 licenses and certificates for teachers, including preprimary
- 11 teachers, and the requirements for an endorsement of teachers as
- 12 qualified counselors AND AN ENDORSEMENT OF TEACHERS FOR TEACHING
- 13 A FOREIGN LANGUAGE IN AN ELEMENTARY GRADE in the public schools
- 14 of the state.
- (2) Beginning September 1, 1991, the state board shall only
- 16 issue a teaching certificate to a person who has passed both a
- 17 basic skills examination and each appropriate subject area exami-
- 18 nation for each subject area in which he or she is to be
- 19 certified. Beginning September 1, 1991, persons holding teaching
- 20 degrees from out-of-state teacher preparation institutions and
- 21 who apply for a Michigan teacher's certificate shall be required
- 22 to pass both a Michigan state board approved basic skills exami-
- 23 nation and each appropriate Michigan state board approved subject
- 24 area examination.
- 25 (3) Not later than June 1, 1988, the department, based upon
- 26 criteria recommended pursuant to subsection (5), shall provide to
- 27 state board approved teacher education institutions state board

- 1 approved guidelines and criteria for use in the development or
- 2 selection of a basic skills examination, and not later than
- 3 June 1, 1989, approved guidelines and criteria for use in the
- 4 development or selection of subject area examinations.
- 5 (4) Not later than January 1, 1989, the state board, based
- 6 upon criteria recommended pursuant to subsection (5), shall
- 7 develop, select, or develop and select 1 or more basic skills
- 8 examinations, and not later than January 1, 1990, subject area
- 9 examinations that may be used by an approved teacher education
- 10 institution.
- 11 (5) Within 30 days after the effective date of the amenda-
- 12 tory act that adds this subsection NOT LATER THAN JANUARY 18,
- 13 1987, the state board shall appoint an 11-member teacher examina-
- 14 tion advisory committee comprised of representatives of approved
- 15 teacher education institutions and Michigan education organi-
- 16 zations and associations. Not more than 1/2 of the members com-
- 17 prising this committee shall be certified teachers. Not later
- 18 than January 1, 1988, this committee shall recommend criteria to
- 19 be used by the state board in the development, selection, or
- 20 development and selection of 1 or more basic skills examinations,
- 21 and not later than January 1, 1989, criteria to be used by the
- 22 state board in the development, selection, or development and
- 23 selection of subject area examinations. In addition, by those
- 24 dates, the committee shall recommend guidelines for the use and
- 25 administration of those examinations. The basic skills examina-
- 26 tions referred to in this subsection may be developed by the
- 27 state board or selected by the state board from commercially or

- 1 university developed examinations. In addition, an approved
- 2 teacher education institution, pursuant to guidelines and cri-
- 3 teria described in subsection (3), may develop an examination at
- 4 its own expense for approval by the state board. An approved
- 5 teacher education institution that develops its own examination
- 6 -shall-be IS liable for any litigation that results from the use
- 7 of its examination.
- 8 (6) Within-30 days after the effective date of the amenda-
- 9 tory act that adds this subsection NOT LATER THAN JANUARY 18,
- 10 1987, the state board shall appoint a 7-member standing technical
- 11 advisory council comprised of persons who are experts in measure-
- 12 ment and assessment. This council shall advise the state board
- 13 and the teacher examination committee on the validity, reliabili-
- 14 ty, and other technical standards of the examinations that will
- 15 be used or are being used and of the administration and use of
- 16 those examinations.
- 17 (7) Not later than September 1, 1992 and each year thereaf-
- 18 ter, the state board shall submit in writing a report on the
- 19 development or selection and use of the basic skills examination
- 20 and the subject area examinations to the house and senate educa-
- 21 tion committees. The report shall also contain a financial
- 22 statement regarding revenue received from the assessment of fees
- 23 levied pursuant to subsection (9) and the amount of and any pur-
- 24 poses for which that revenue was expended.
- 25 (8) The basic skills examination and the subject area exami-
- 26 nations required by this section may be taken at different times

- 1 during an approved teacher preparation program, but must be
- 2 passed before a person is enrolled for student teaching.
- 3 (9) The department, or if approved by the state board, a
- 4 private testing service, may assess a fee for taking the basic
- 5 skills and the subject area examinations. The fees, which shall
- 6 be set by the state board, shall not exceed \$50.00 for a basic
- 7 skills examination -nor OR \$75.00 for a subject area
- 8 examination. Fees received by the department shall be expended
- 9 solely for administrative expenses that it incurs in implementing
- 10 subsections (2) to (12).
- 11 (10) As used in this section:
- 12 (a) "Basic skills examination" means an examination devel-
- 13 oped or selected by the state board or developed pursuant to sub-
- 14 section (5) by an approved teacher education institution for the
- 15 purpose of demonstrating the applicant's knowledge and under-
- 16 standing of basic language and mathematical skills and other
- 17 skills necessary for the certificate sought, and for determining
- 18 whether or not a teacher education graduate is eligible for a
- 19 provisional or probationary Michigan teaching certificate. Not
- 20 later than June 30, 1987, the department shall advise the state
- 21 board and the legislature whether or not the department recom-
- 22 mends that the basic skills examination include an examination of
- 23 a person's knowledge and understanding of 1 or more of the
- 24 following: brain function, learning styles, and learning
- 25 processes.
- 26 (b) "Subject area examination" means an examination related
- 27 to a specific area of certification, which examination has been

- 1 developed or selected by the state board for the purpose of
- 2 demonstrating the applicant's knowledge and understanding of the
- 3 subject matter and determining whether or not a teacher education
- 4 graduate is eligible for a provisional or probationary Michigan
- 5 teaching certificate.
- 6 (11) The state board shall certify as qualified the supervi-
- 7 sors required in section 1506. The state board shall certify
- 8 teachers as qualified to teach the class described in section
- 9 1507(1), based upon the recommendation of a teacher training
- 10 institution, upon an evaluation of the teacher's educational
- 11 qualifications and experience, and upon any additional require-
- 12 ments the state board considers necessary.
- 13 (12) The state board shall promulgate rules for the imple-
- 14 mentation of this section.
